



## KEY INVESTOR INFORMATION

This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

### UBAM - Global Bond Total Return, a sub-fund of UBAM

UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in bonds, money market instruments and derivatives denominated in multiple currencies such as but not only limited to US Dollars, Euros, Japanese Yen, Pounds Sterling and Swiss Francs.

Derivatives may include but are not limited to Credit Default Swaps ("CDS"), futures, forward and options.

The Fund is actively managed with a total return approach and seeks a positive performance above the prevailing cash rate in the reference currency of any given share class.

A performance fee -defined in the Past Performance section- is applied to some share classes ("Benchmark 1").

The Fund's performance can also be compared to a benchmark composed of 80% Bloomberg Barclays Global Aggregate 1-10 years Total Return Index hedged into US Dollars and 20% of ICE BofAML Global High Yield Index hedged into US Dollars ("Benchmark 2").

Benchmark 2 is for information purposes only. The Fund's investment objective does not aim to replicate this Benchmark 2 or to define the Fund's investment universe.

Although the Fund's risk profile will be similar to the Benchmark 1 and 2, the portfolio's investments will deviate materially from the Benchmarks' constituents in respect to countries, sectors, issuers and instruments, in order to take advantage of specific investment opportunities.

The Fund may invest up to:

- 50% of its nets assets in High Yield
- 45% of its nets assets in Emerging countries (including China through Bond Connect)
- 20% of its nets assets in Contingent Convertible Bonds (Cocos)
- 10% of its nets assets in worldwide Equity including Emerging countries and equity derivatives.

The Fund's value is calculated and expressed in US Dollar.

The currency hedging aims to hedge the currency risk versus the benchmark while maintaining the active currency risk taken by the Investment Manager.

The relevant benchmark is 80% Bloomberg Barclays Global Aggregate 1-10 years Total Return Index hedged into USD + 20% ICE BofAML Global High Yield Index hedged into USD.

This benchmark is for information purposes only. The Fund's investment objective does not aim to replicate this benchmark nor to define the Fund's investment universe. The benchmark may not be representative of the Fund's risk profile.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive markets are closed: United States (US), United Kingdom (UK), Eurex.

Any income received by the Fund is reinvested (capitalisation share class).

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

This is due to investments in fixed income securities on Emerging and high yield markets.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Counterparty risk:** The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honor its contractual obligations. This may result in a financial loss for the Fund.

**Credit risk:** The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Emerging country risk:** The Fund invests in developing overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

## Charges

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.

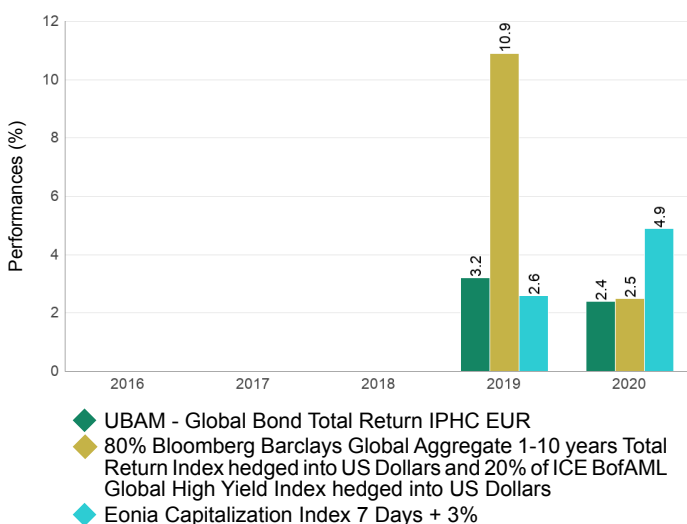
