### UBAM - Europe 10-40 Convertible Bond, a sub-fund of UBAM

UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

#### Objectives and investment policy

The Fund seeks to grow your capital and generate income primarily by investing as a master / feeder structure at least 85% in the sub-fund UBAM Convertibles Europe 10-40 part of the French Sicav UBAM Convertibles. The Master, UBAM Convertibles Europe 10-40, is an investment fund offering exposure to the Convertible Bond asset class, mainly from Europe.

It is an actively managed, well diversified portfolio mainly made up of euro-denominated convertible bonds or equivalent bonds, rated or unrated, whose underlying and/or issuer is a company with its headquarters in an OECD member state or listed on a European Market, with substantial weighting given to Europe countries. Thus the Master may be exposed to high yield bonds.

In addition, the Master may invest up to 20 % in non convertibles or similar bonds. The Master currency risk will be hedged systematically with the aim of achieving a residual direct exposure of less than 10%.

The Fund may invest up to:

- 15% of its net assets in liquid assets or derivative financial instruments (for hedging purpose).

Convertible bonds are debt instruments that can be converted into equities under certain conditions. This means that they have characteristics comparable to those of equities while maintaining the characteristics of conventional bonds.

High yield bonds are issued by companies whose business is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products.

The Master has a target exposure to equity markets of between 10% and 40% (with a maximum of 50%).

For managing overall exposure to equities and interest-rate risk, the Master may use derivative instruments (futures, options, etc.) in order to expose and/or hedge the portfolio.

The Fund's value is calculated and expressed in Euros.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: France (FR)

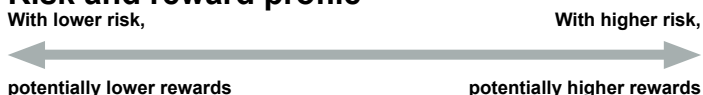

The recommended holding period is minimum three years.

Considering that less than 100% of the Fund is invested in the Master, the Fund's performance can be slightly different than the Master's.

Any income received by the Fund is distributed (distribution share class).

#### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Risk Category 3 reflects limited potential gains and/or losses for the portfolio.

This is due to investments in bonds on the European market.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Credit risk:** The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Counterparty risk:** As the Fund uses over-the-counter derivatives, there is a risk that the counterparty to the transactions will wholly or partially fail to honour its contractual obligations. This may result in a financial loss to the Fund.

## Charges

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.

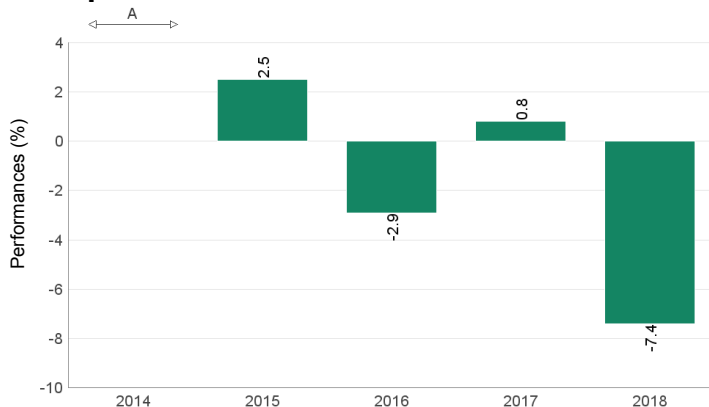
