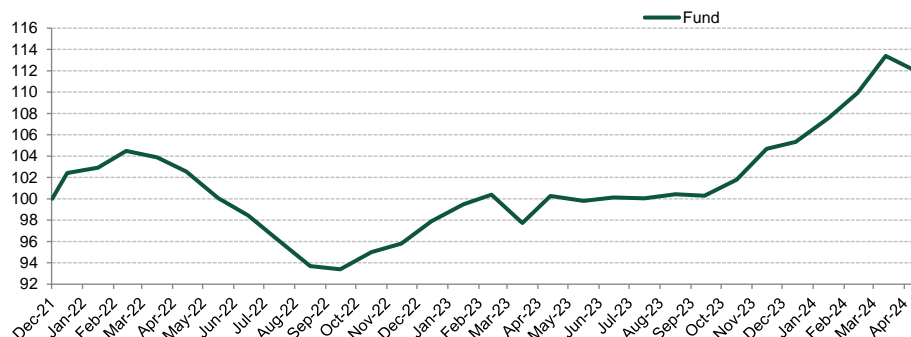

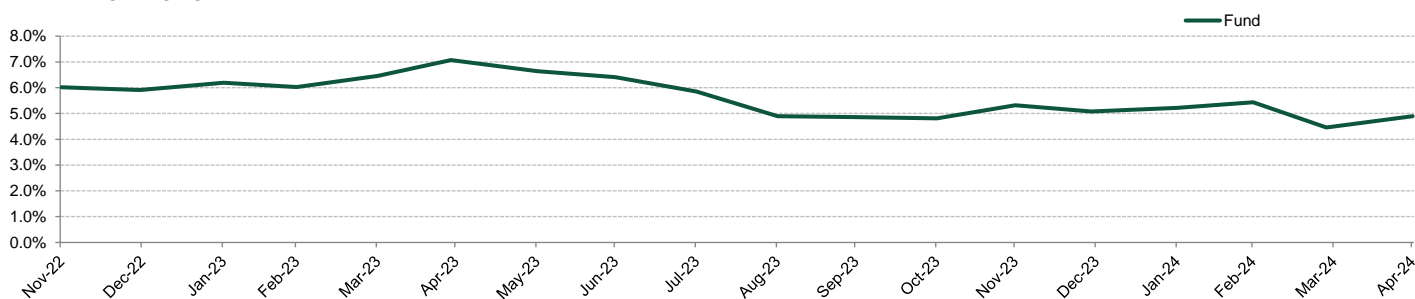
HISTORICAL TRACK RECORD *
