U ACCESS is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in convertible bonds and exchangeable bonds issued primarily by companies (i) having their registered office, or (ii) carrying on a major part of their commercial activity, or (iii) as holding companies owning predominant interests in companies with their registered office in the People's Republic of China ("PRC") and / or in exchangeable bonds issued by the PRC.

On an ancillary basis this Fund may invest its net assets in equities and other similar transferable securities, warrants on transferable securities, bonds with warrants on transferable securities, bonds and other debt securities (excluding asset-backed securities (ABS) and mortgage-backed securities (MBS)), money market instruments issued primarily by the PRC or by companies (i) having their registered office, or (ii) carrying on a major part of their commercial activity, or (iii) as holding companies owning predominant interests in companies with their registered office in the PRC.

The Fund is actively managed and well diversified.

The Fund is not managed in reference to a benchmark.

The Fund may invest up to:

- 100% of its net assets in securities issued or guaranteed by the PRC

The Fund's value is calculated and expressed in Renminbi.

The share currency risk in relation to the base currency CNH is mainly hedged.

Investors in the Fund can subscribe and redeem units on a weekly basis, each Monday, except if it is a bank holiday in Luxembourg or if the decisive market is closed: Shanghai (CN).

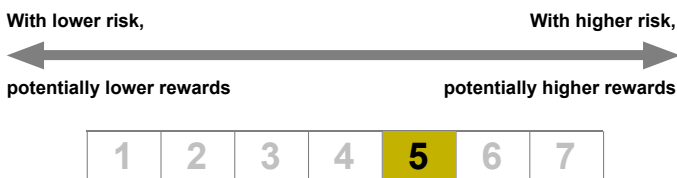

### Risk and reward profile

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**RQFII licence quota risk:** The Chinese regulatory authorities have wide discretionary prerogatives to add regulation or modify the current rules. The RQFII licence is subject to ongoing review by the Chinese authorities and may be revised, reduced or withdrawn at any time.
