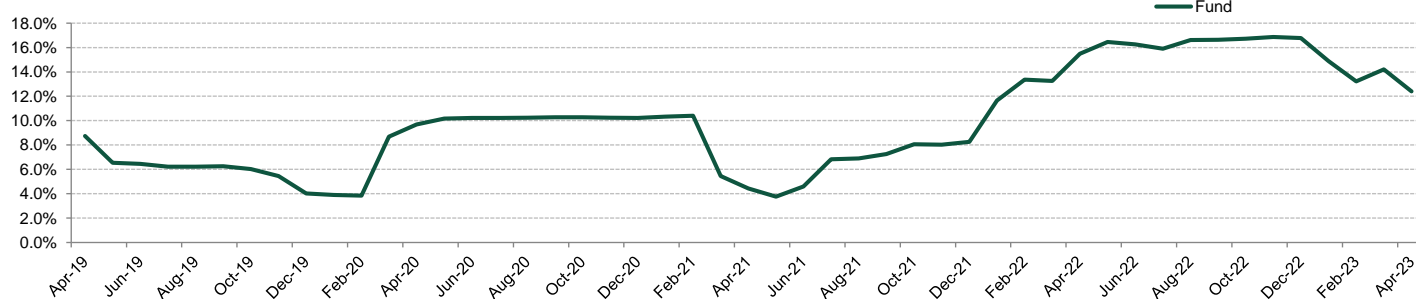

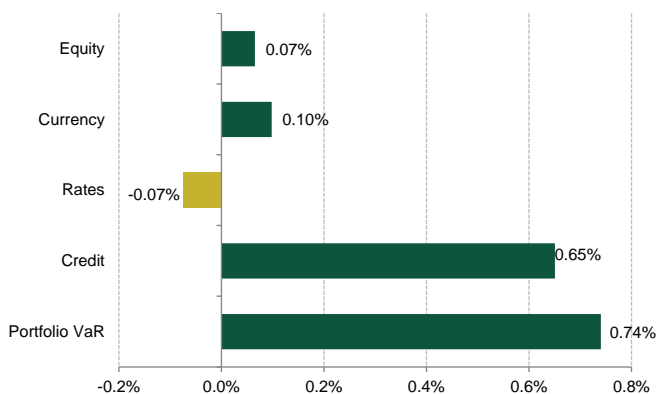

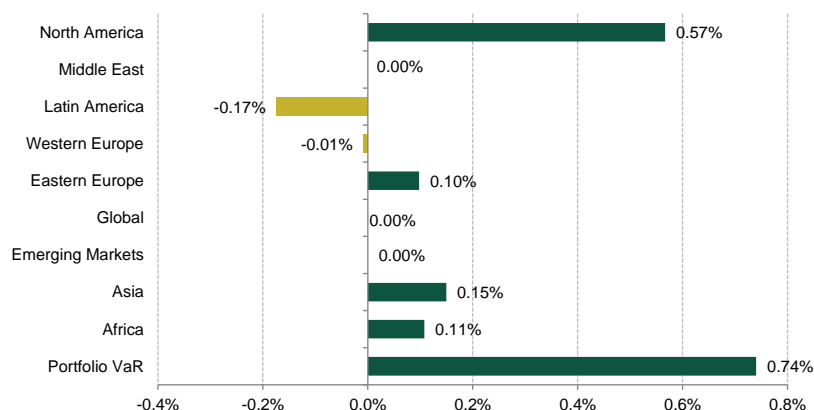

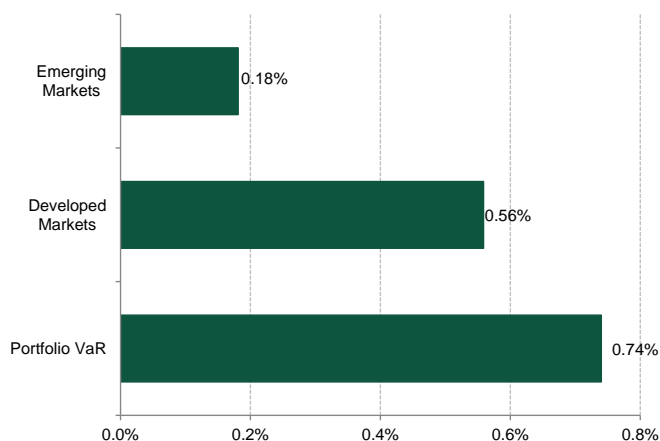
BY ASSET CLASS (VaR 95%*)



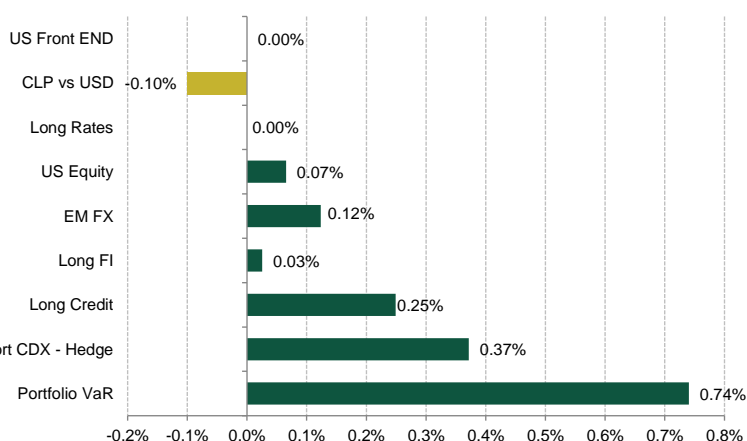
BY REGION (VaR 95%*)

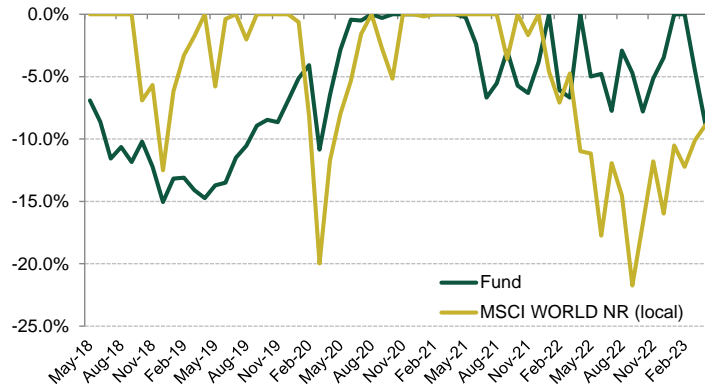

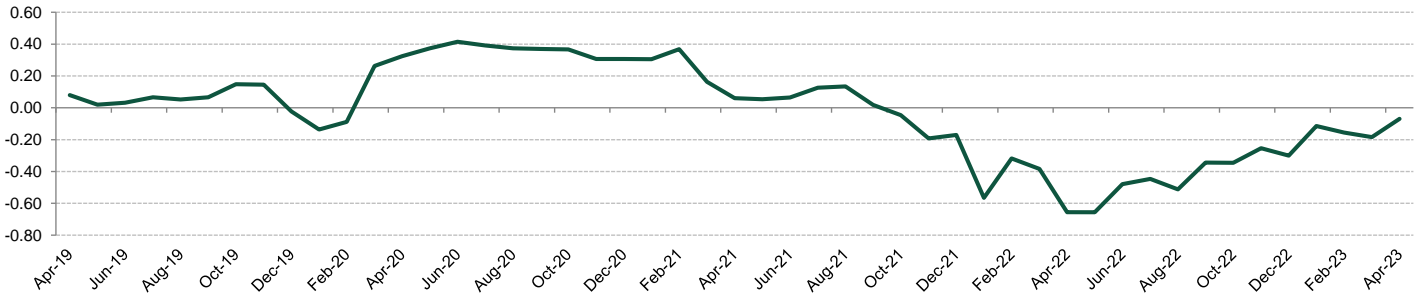

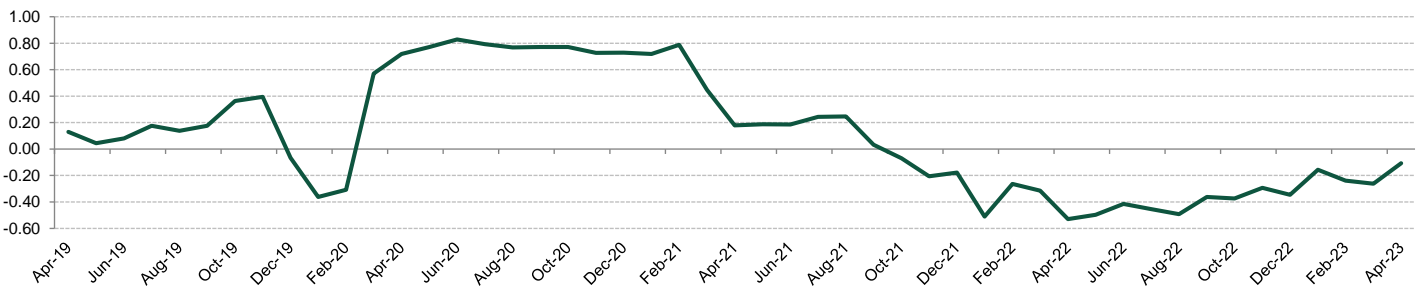


◆ 12 MONTH BETA EQUITY EVOLUTION



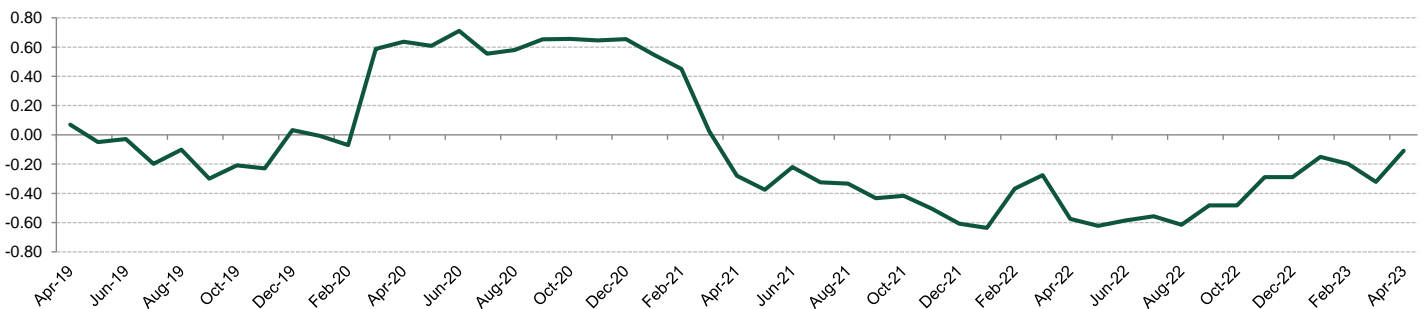
