







The ESG Quality Score is mapped to a Letter Rating as follows: [8.6,10] - > AAA; [7.1, 8.6] -> AA; [5.7, 7.1] -> A; [4.3, 5.7] -> BB; [2.9, 4.3] -> BB; [1.4, 2.9] -> B, [0; 1.4] -> CCC.

#### ESG Quality Score
