UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in fixed or variable rate bonds in hard currency such (but not limited to) Euro and US Dollar issued by Public Authorities or quasi sovereign which are domiciled in frontier countries or economically linked, directly or indirectly to an issuer domiciled in a Frontier country or linked to frontier country risk.

The Fund is actively managed and well diversified, investing mainly in securities denominated in US Dollars and Euros.

The Fund is not managed in reference to a benchmark.

The Fund will invest a minimum of 2/3 of its net assets in products with a minimum rating of B- (S&P or FITCH), B3 (Moody's) or an equivalent rating by another rating agency and up to 1/3 of its net assets in products with a rating below B- (S&P or FITCH), B3 (Moody's) or an equivalent rating by another rating agency.

The Fund may invest up to:

- 100% of its net assets in Frontier countries

this exposure can be increased up to 120% through derivatives

- 100% of its net assets in High yield

this exposure can be increased up to 120% through derivatives

- 20% of its net assets in Frontier corporate bonds

- 20% of its net assets in Contingent Convertible capital bonds (CoCos)

Overall, up to 20% of the Fund's investments may be carried out in local countries' currencies and bonds denominated in a hard currency other than USD (e.g. EUR) will be hedged.

High yield bonds are issued by companies whose business is more sensitive to the economic cycle and therefore pay a higher interest rate than investment grade bonds to compensate for the increased risk.

Exposure to high yield or investment grade bonds can be direct or through CDS (Credit Default Swap). CDS offer a liquid exposure to high yield and bear minimal interest rate risk.

The Fund's value is calculated and expressed in US Dollars.

The currency risk in relation to the base currency USD is mainly hedged.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: United States (US).

The recommended holding period is minimum three years.

Any income received by the Fund is reinvested (capitalisation share class).

Risk and reward profile

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Emerging and Frontier countries risk: The Fund invests in developing overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries. Emerging countries risk are magnified in Frontier countries.

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honor its contractual obligations. This may result in a financial loss for the Fund.

Credit risk: The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

Currency risk: The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

Charges

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.

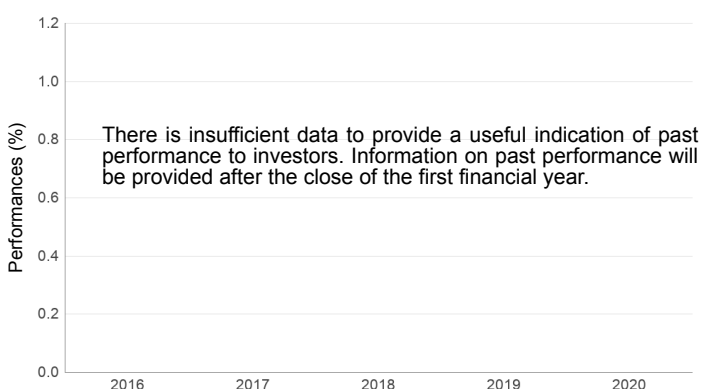
