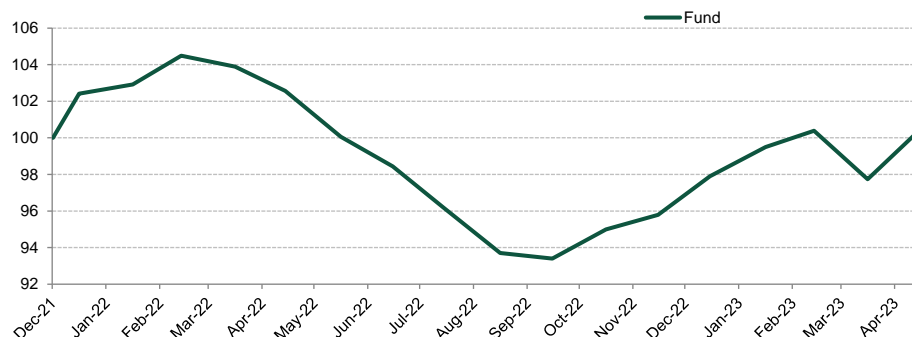

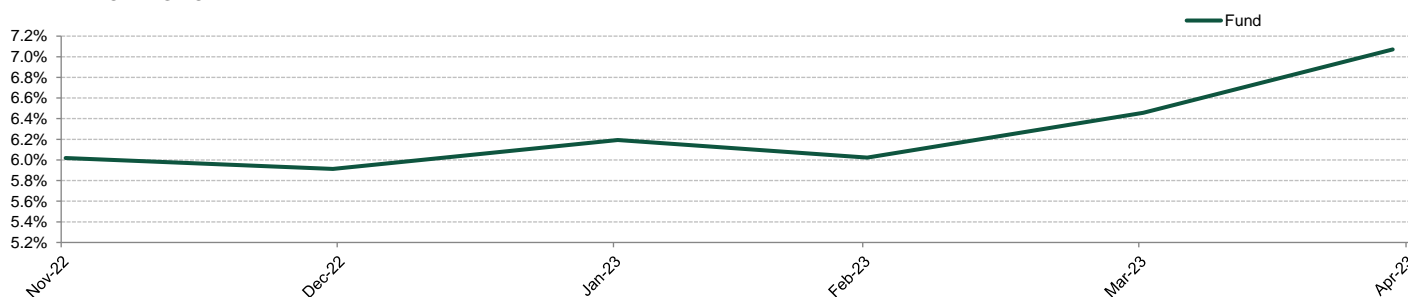
HISTORICAL TRACK RECORD*
