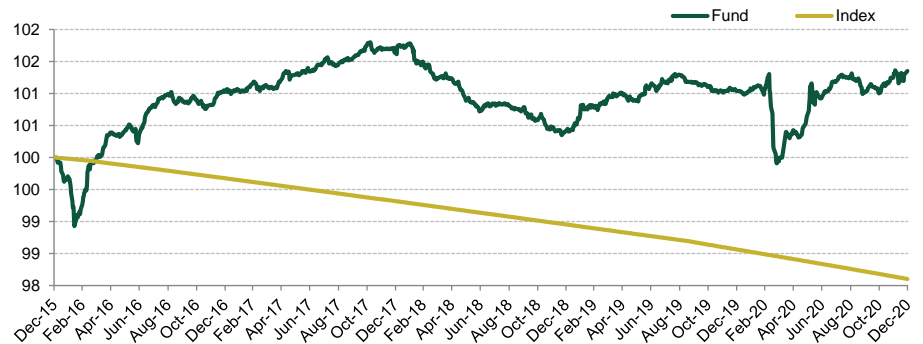

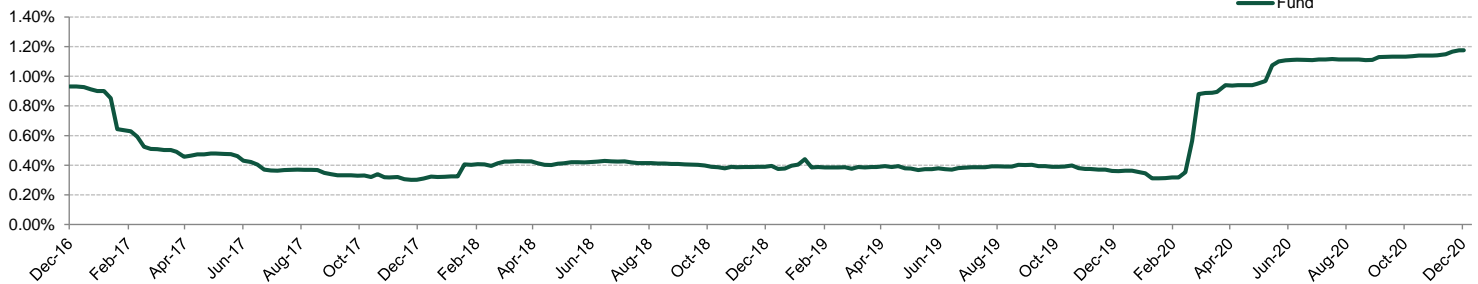
5-YEAR TRACK RECORD *

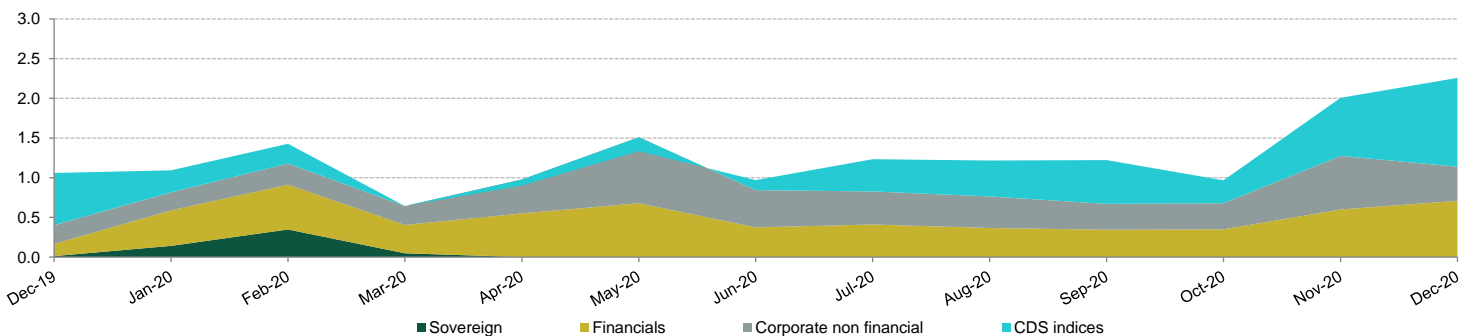

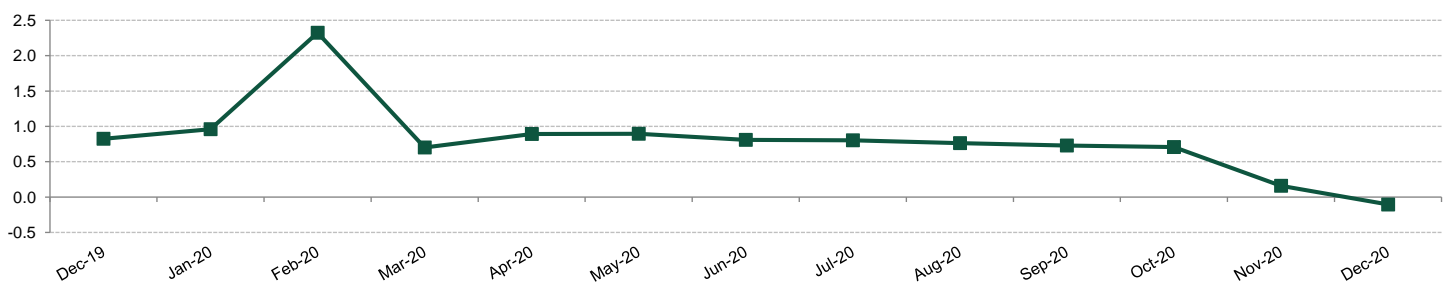
◆ CREDIT EXPOSURE IN RASD*
