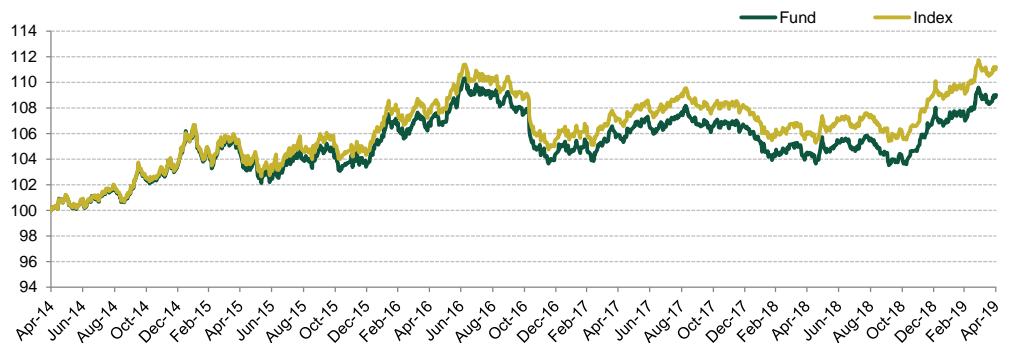

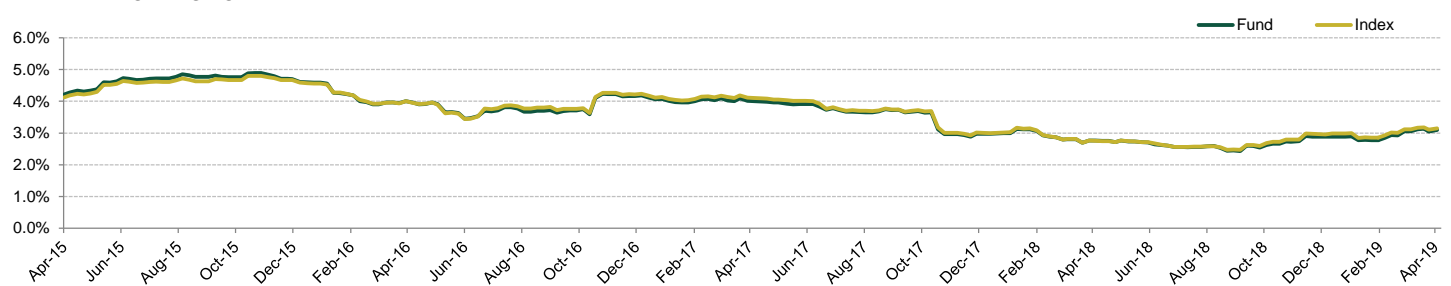
5-YEAR TRACK RECORD *

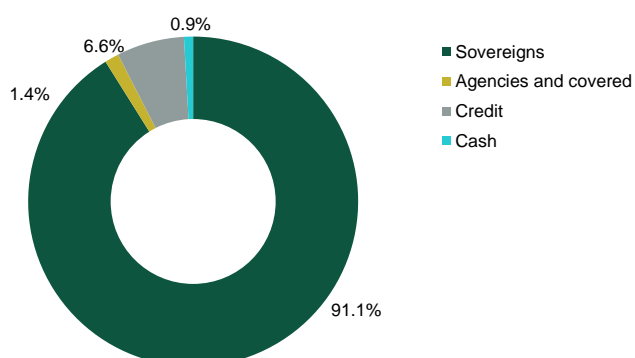

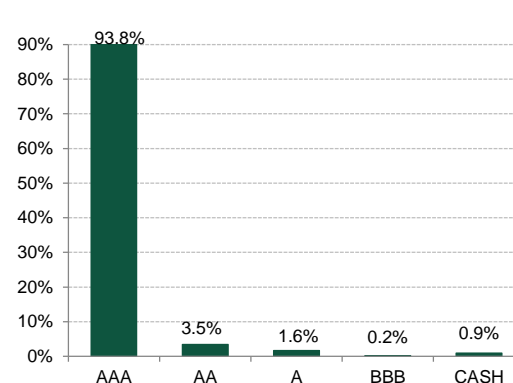

SECTOR ALLOCATION *



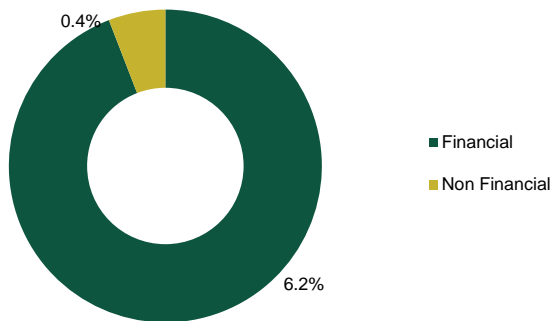
RATING ALLOCATION *

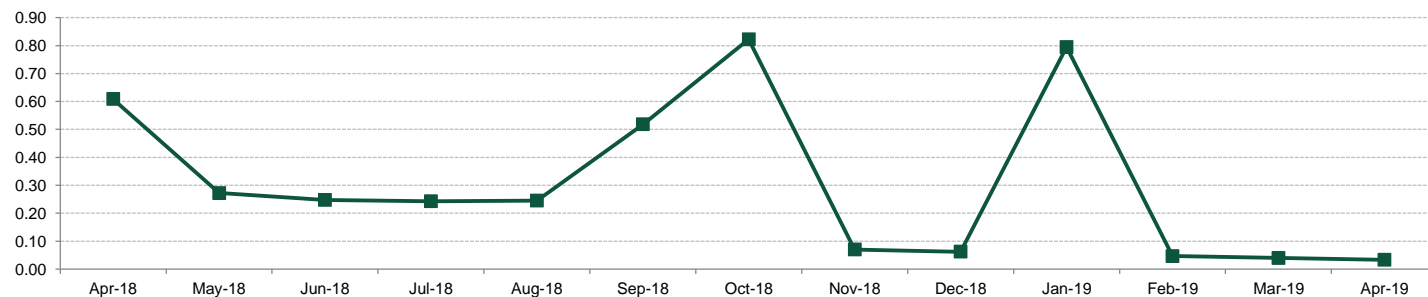
