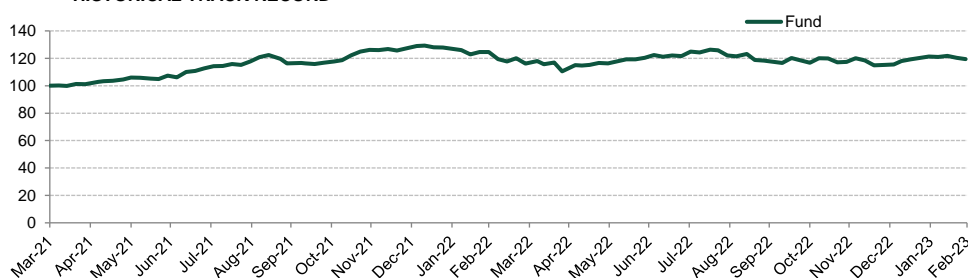

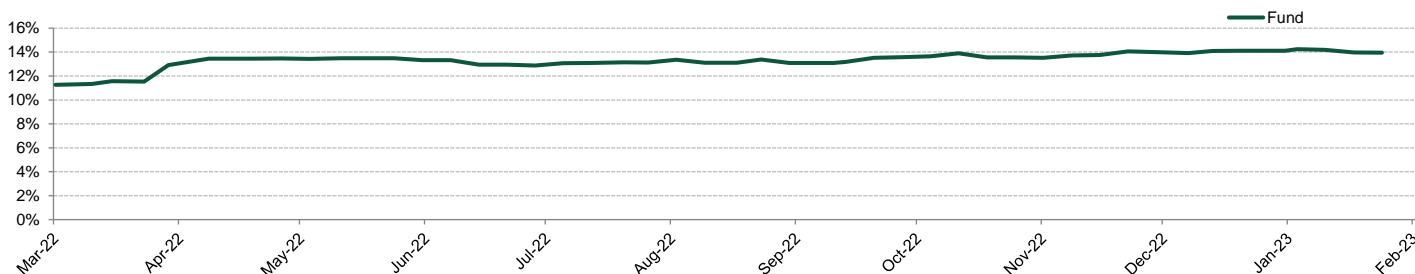

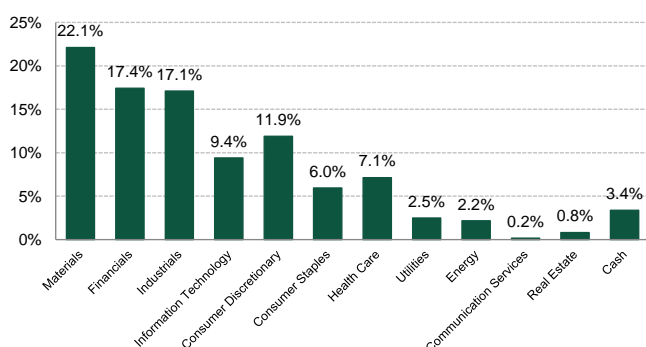

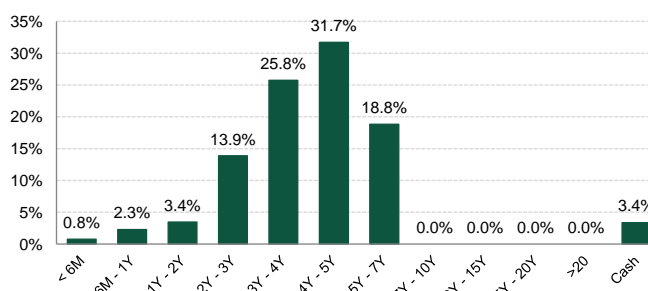

### SECTOR ( Weight)

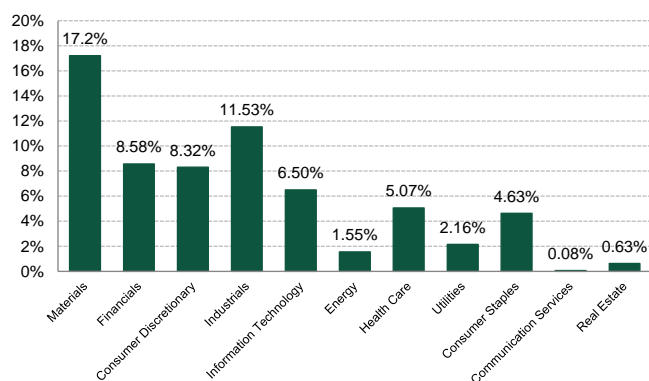

### MATURITY STRUCTURE

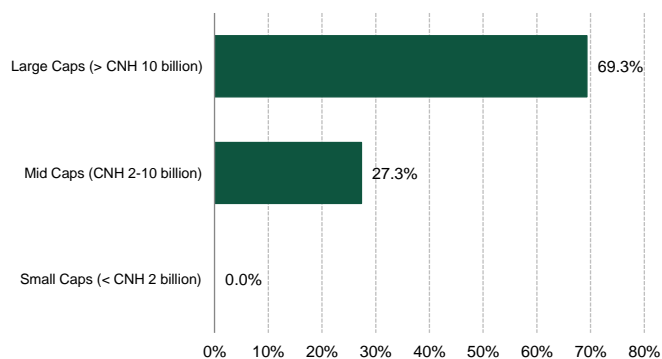


## ◆ SECTOR ( Equity Sensitivity)

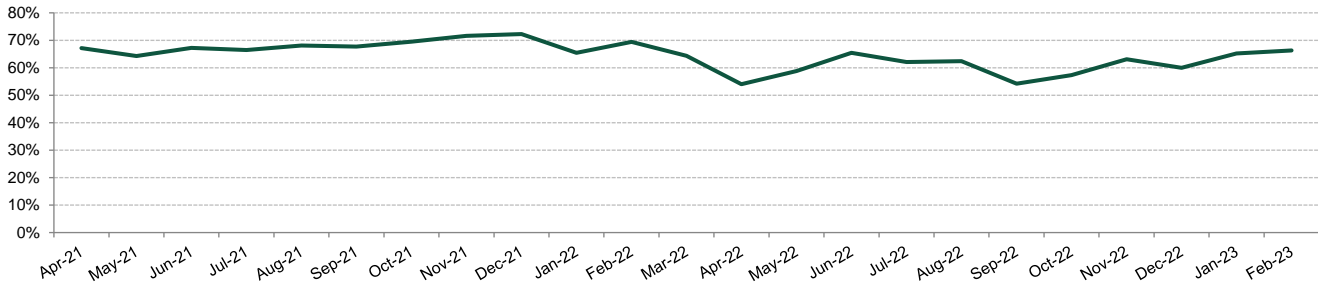

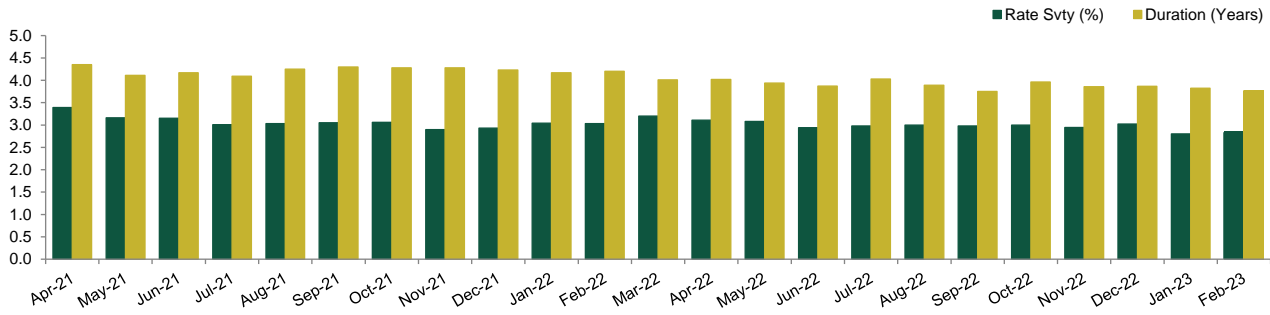
