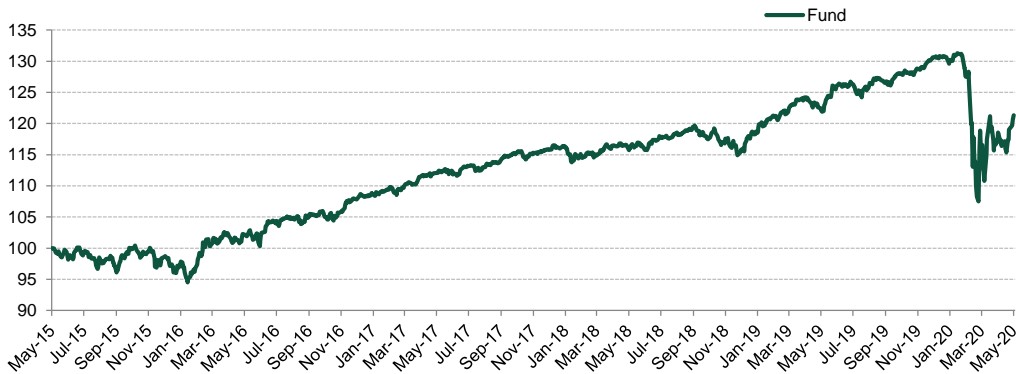

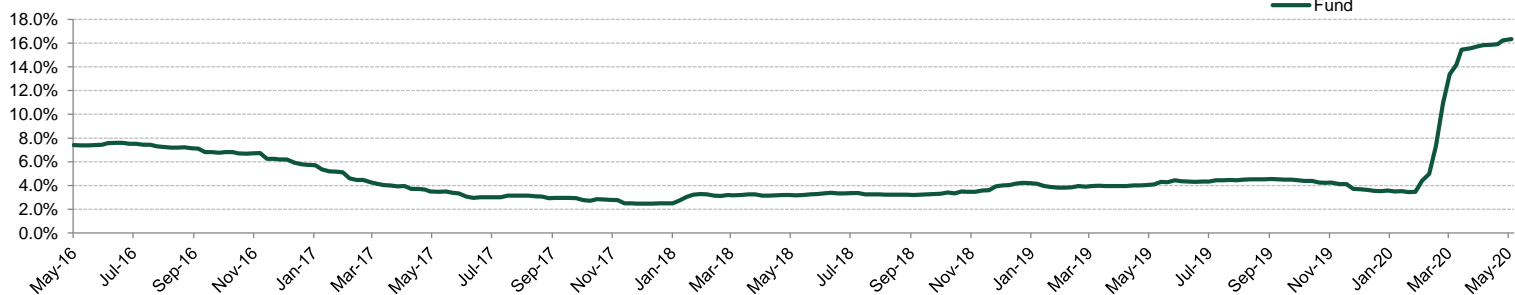
5-YEAR TRACK RECORD *

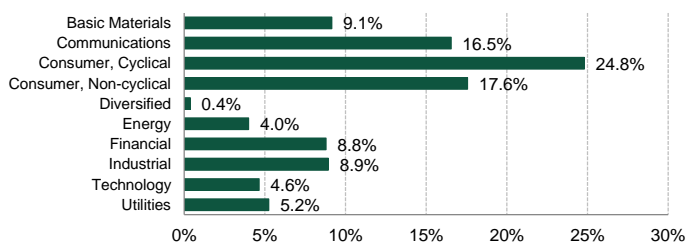

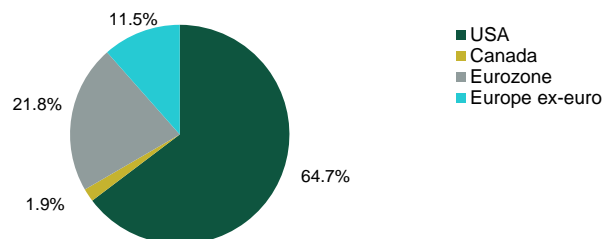
BREAKDOWN OF THE CDS INDICES EXPOSURE *



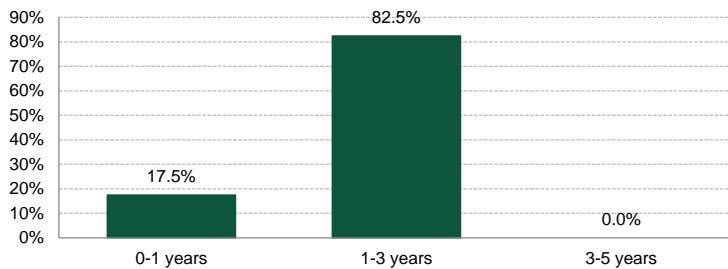

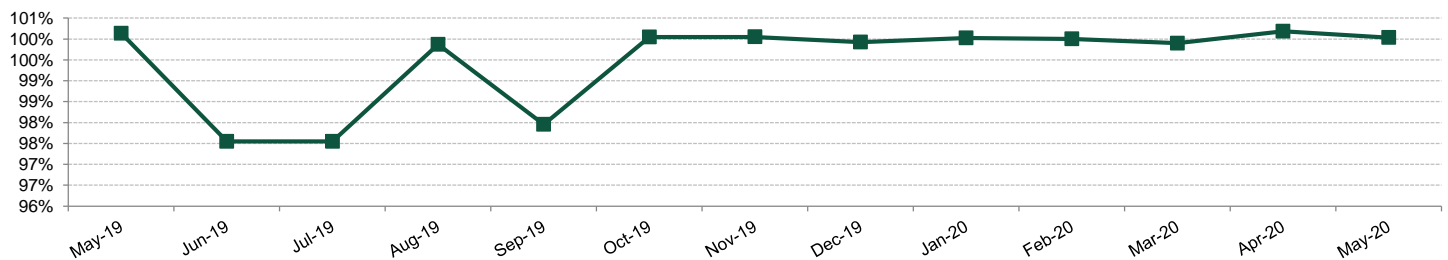

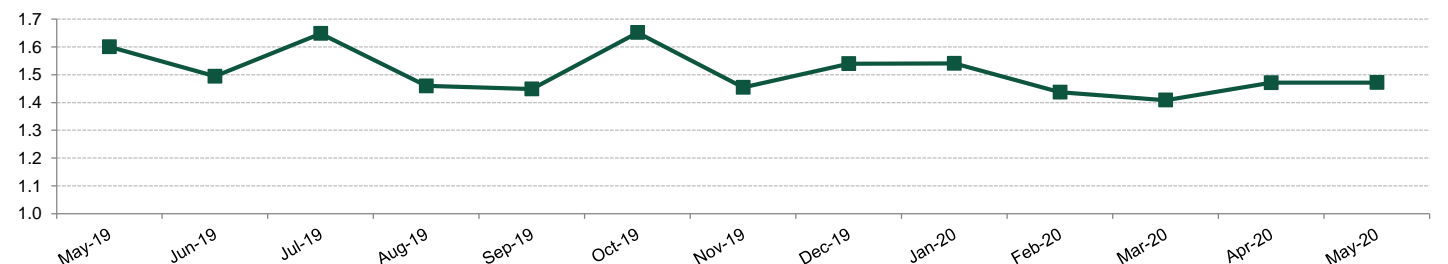

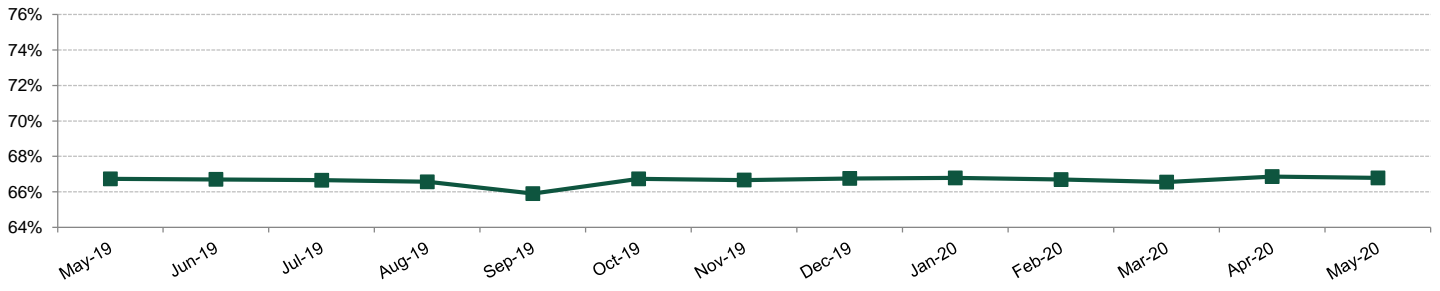

♦ INTEREST RATE EXPOSURE



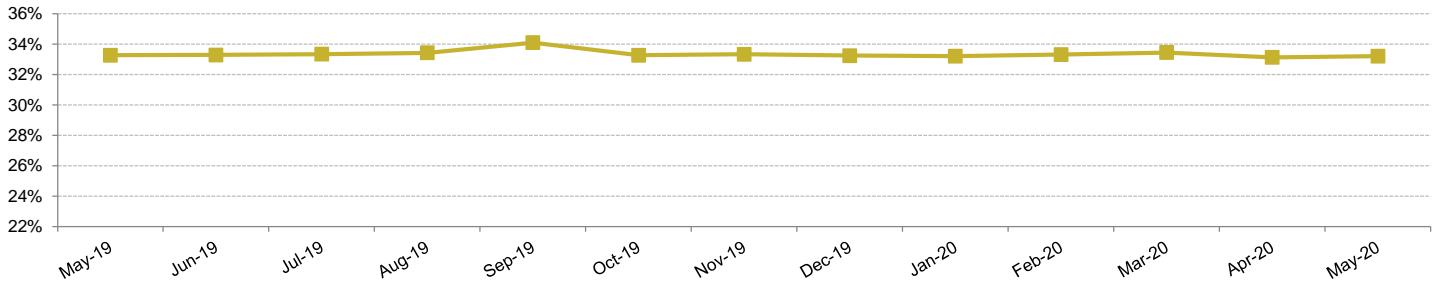
