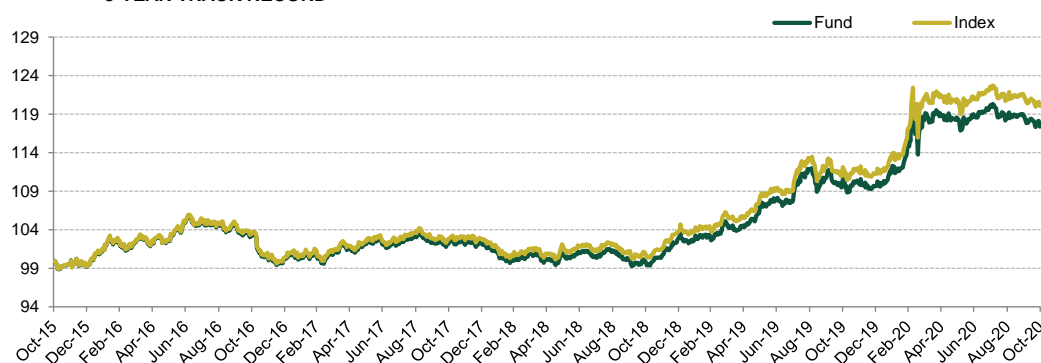

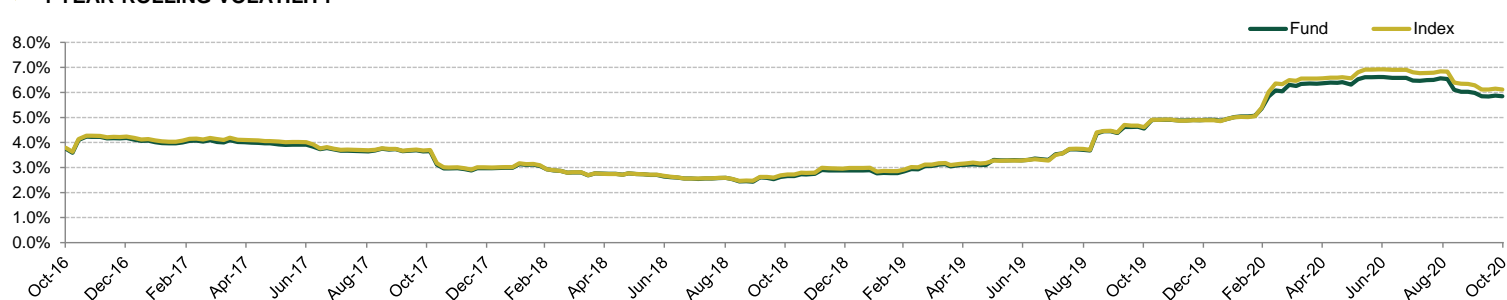
5-YEAR TRACK RECORD *

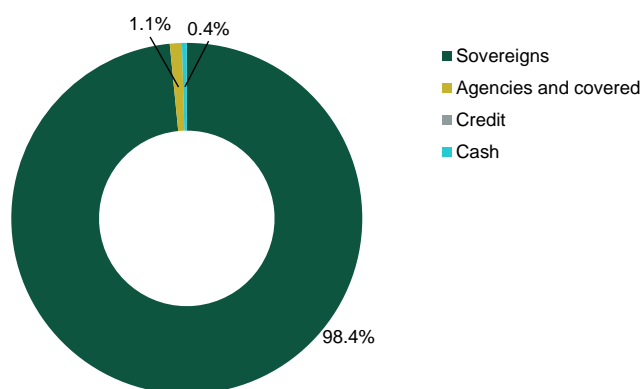

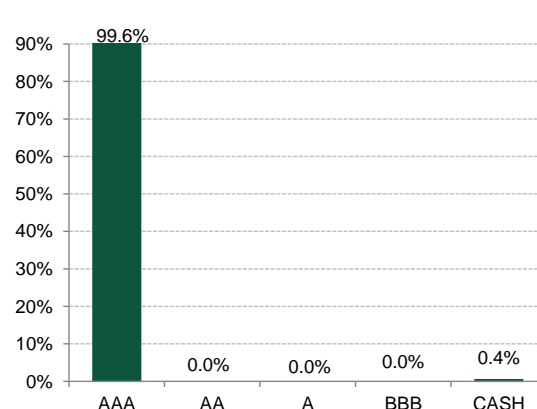

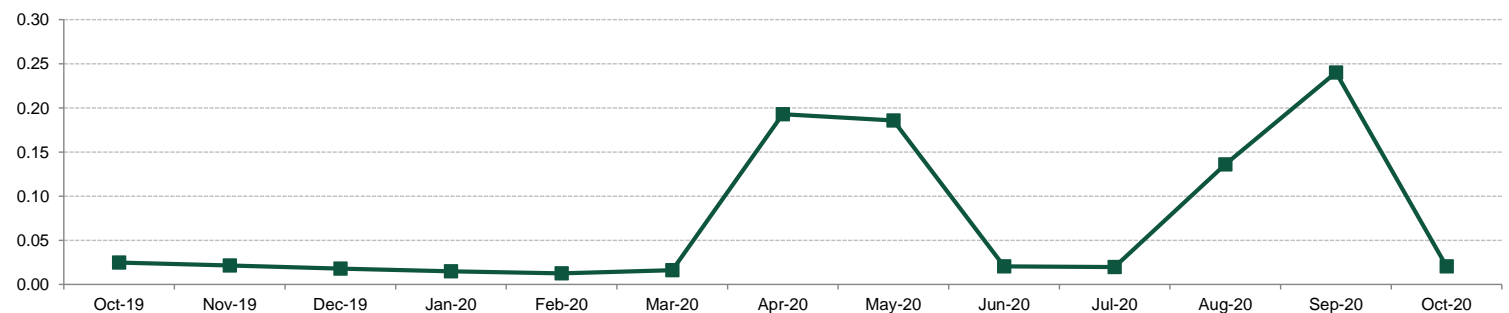
