UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in equities with exposure to growth opportunities across the world, including emerging countries.

The investment concept is stock selection driven and focuses on companies with above market average revenue growth or improving growth rates as well as companies providing consistently economic value-add, i.e. sustainably earning their cost of capital.

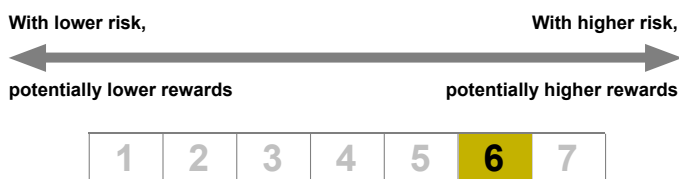
The qualitative sustainable analysis is partly based on inputs provided by MSCI ESG Research, and, for companies not covered by MSCI, on the own analysis of the Investment Manager.

The primary sustainable objective for which the Fund will be able to measure the positive impact is the lower carbon intensity versus the MSCI AC World ("the Benchmark").

The Investment Manager performs a negative screening and a norms-based screening to filter the investment universe. ESG related information is entering the suitability screen of the stock selection process. The portfolio construction will consider ESG criteria as well as the contribution to risk that arises from ESG exposures. Company specific and portfolio factors including ESG developments are considered when constructing and monitoring the portfolio.

A performance fee in reference to the Benchmark is applied to some share classes. The Benchmark is not representative of the Fund's risk profile and the portfolio's investments will deviate materially from the Benchmark's constituents in respect to countries, sectors, issuers and instruments, in order to align the portfolio with the environmental and/ or social characteristics promoted by the Fund and/or in order to take advantage of specific investment opportunities.

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Risk category 6 reflects a very high potential gain and/or loss in the value of the portfolio.

This is due to investments in equities on worldwide markets.

Historical data such as that used to calculate the synthetic indicator cannot be considered as a reliable indication of the Fund's future risk profile.

The recommended holding period is minimum five years.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Counterparty risk:** As the Fund uses over-the-counter derivatives, there is a risk that the counterparty to the transactions will wholly or partially fail to honour its contractual obligations. This may result in a financial loss to the Fund.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Emerging country risk:** The Fund invests in developing overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. **ESG and Sustainability risk:** it may result in a material negative impact on the value of an investment and performance of the Fund. Assessment of sustainability risks is complex and requires subjective judgments, which may be based on data which is difficult to obtain and/or incomplete, estimated, out of date or otherwise materially inaccurate. All or part of said data may come/originate from third parties.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.

## Charges

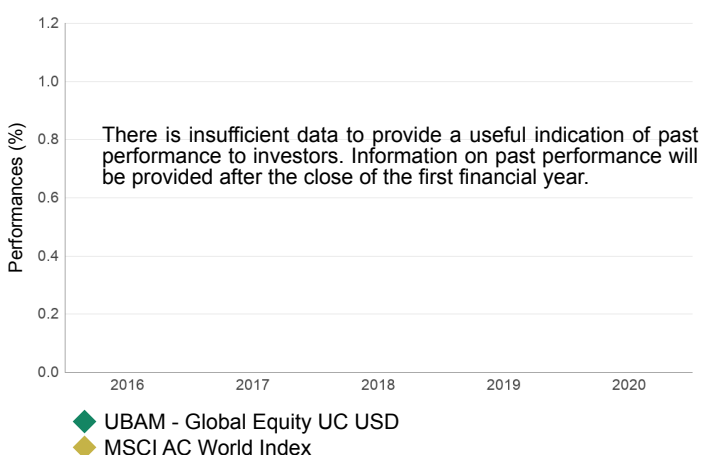
