ABOUT THE FUND

The Fund seeks to grow capital and generate income primarily by investing in global credit market with a credit rating of B+ (S&P or FITCH), B1 (Moody's) or above. The Fund is actively managed.


The Fund is allowed to invest in currencies other than its base currency (USD), but the currency risk is limited to 20% of the net

A minimum of 50% of the bond investments will be in issuers deemed to maintain sustainable characteristics with a minimum Environmental, Social and Governance (ESG) rating of BBB for developed market issuers and BB for emerging market issuers as measured by MSCI ESG research or if such rating is not available an equivalent internal rating assigned by the Investment Manager. ESG investment strategy is based on three pillars: (i) Sector exclusion according to the UBP Responsible Investment policy; (ii) ESG integration to select issuers through the analysis of ESG and financial factors; (iii) a preference for Green, Social and Sustainability bonds. The Fund is not managed in reference to a benchmark.

The Fund may invest its net assets up to:

- 100% in High Yield
- 100% in Investment Grade
- 50% in Emerging Countries (including China through Bond Connect)
- 20% in Contingent Convertible Bonds (Cocos)
- 20% in asset backed securities (ABS)
- 10% in equity, including equity derivatives

PERFORMANCE EVOLUTION USD (NET OF FEES)







High-yield bond

Bonds with high interest rates and high risk exposure. The issuers of such securities are often companies with a low credit rating.

High-yield fund

fund for high-yield bonds (i.e. bonds with low credit ratings).

Investment gradeA rating provides information about the creditworthiness of a debtor. The higher the rating, the less likely the debtor is to default. A distinction is made between high-quality (investment grade) and speculative bonds (high-yield or junk bonds). For investment-grade bonds, Standard & Poor's issues ratings from AAA to BBB, while Moody's ratings range from Aaa to Baa.

Credit default swap (CDS)

Credit default swap (CDS) is a kind of insurance against the risk of credit default.

Upon conclusion of a credit default swap agreement, the protection seller pledges himself to pay compensation to the protection buyer if a specified credit event occurs (eg default or late payment). In return, the protection seller receives a premium. The amount of the CDS premium depends primarily on the creditworthiness of the reference debtor, the definition of the credit event and the maturity of the contract.

Benchmark

Derivatives

Index used as basis for measuring the performance of an investment fund. Also called reference index or comparison index.

Derivatives
Derivatives are financial instruments whose prices depend on the price movements in a reference variable, known as the underlying. Underlying assets may be shares, equity indices, government bonds, currencies, interest rates, commodities like wheat and gold, or also swaps. Derivative financial instruments may be unconditional forward transactions or they may be options. They are traded either on futures and options exchanges on standardised terms, or over-the-counter (OTC) on freely negotiated terms. Changes in the price of the underlying lead in certain situations to considerably higher price fluctuations in the derivative. Derivatives can be used to hedge against differences between to speculate on price changes (trading) or to take advantage of price differences between markets (arbitrage).

Duration is the average time to payout. This key figure is used to measure the influence of interest rate movements on the price of a bond or bond fund. Duration is defined in years (e. g. 3-year duration means that the value of a bond would increase by 3% if interest rates fall by 1% and vice versa).
