UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in equities with exposure to growth opportunities across the world, including emerging markets.

In addition, the Fund may invest in a discretionary proprietary overlay strategy intended to provide to investors a better risk adjusted return.

The Fund is actively managed and well diversified, investing in several currencies.

The investment concept is stock selection driven and focuses on companies with above market average revenue growth or improving growth rates as well as companies providing consistently economic value-add, i.e. sustainably earning their cost of capital.

A performance fee in reference to the MSCI AC World Net Return Index is applied to some share classes (the "Benchmark"). The Benchmark is not representative of the Fund's risk profile and the portfolio's investments will deviate materially from the Benchmark.

The Fund's value is calculated and expressed in US Dollars.

The currency risk between the currencies of the sub-fund's underlyings and the share's currency is mainly hedged.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg.

The recommended holding period is minimum five years.

Any income received by the Fund is distributed (distribution share class).

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Counterparty risk:** As the Fund uses over-the-counter derivatives, there is a risk that the counterparty to the transactions will wholly or partially fail to honour its contractual obligations. This may result in a financial loss to the Fund.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Emerging market risk:** The Fund invests in developing overseas markets which carry a higher risk than investing in larger established markets. Investments in emerging markets are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in emerging markets rather than more developed countries may encounter difficulties when buying and selling investments. Emerging markets are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.

## Charges

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.

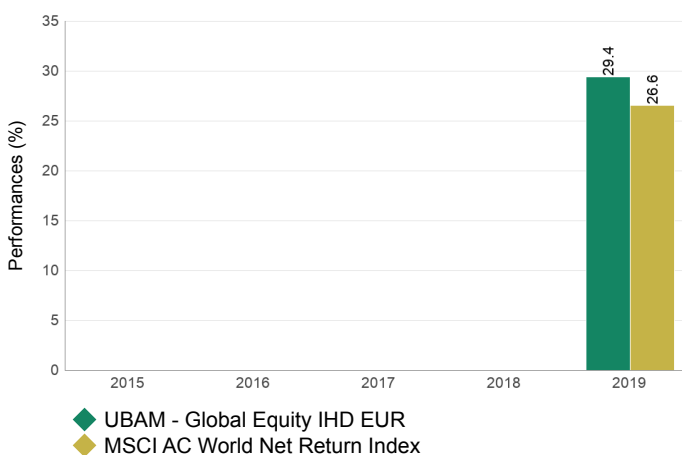
