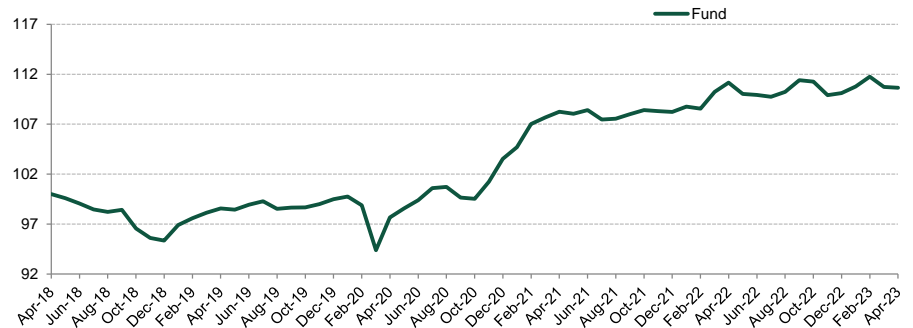

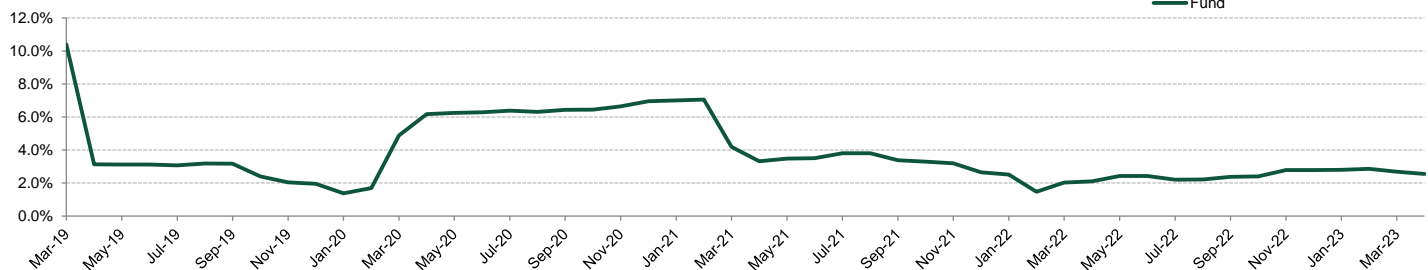
HISTORICAL TRACK RECORD *

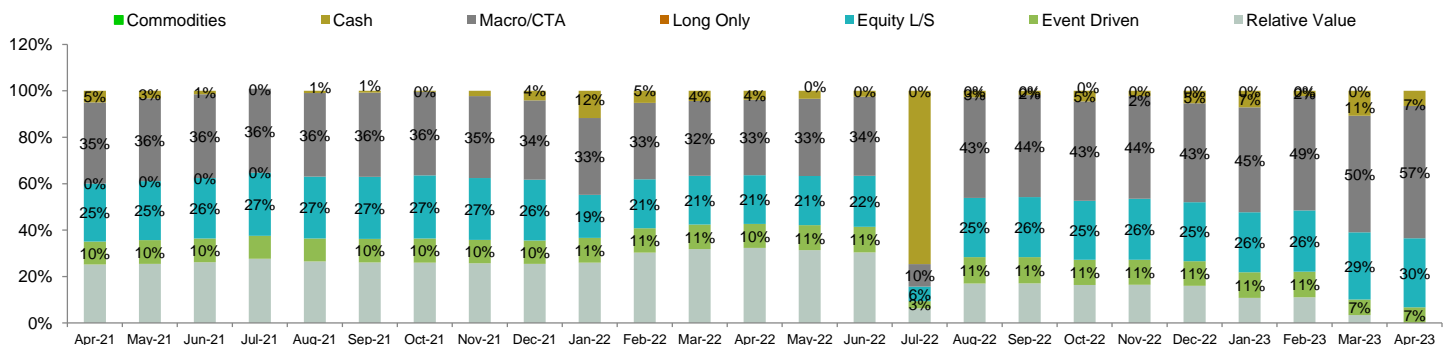

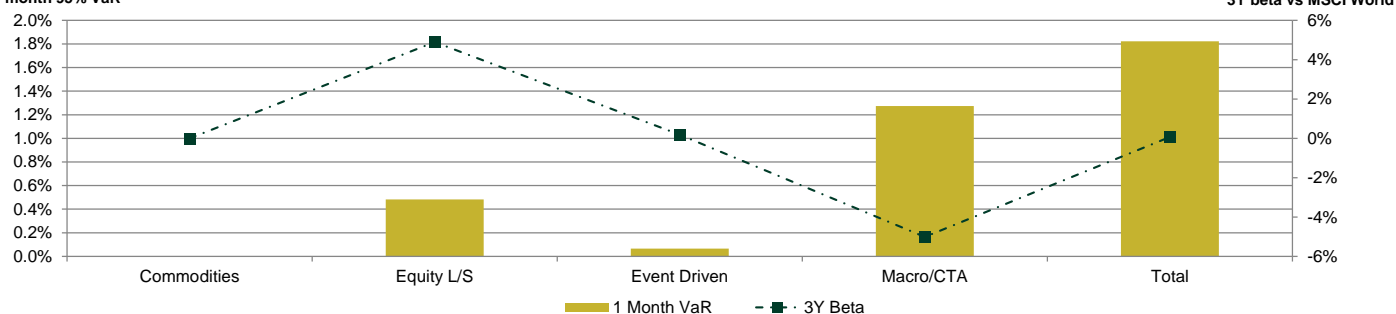
