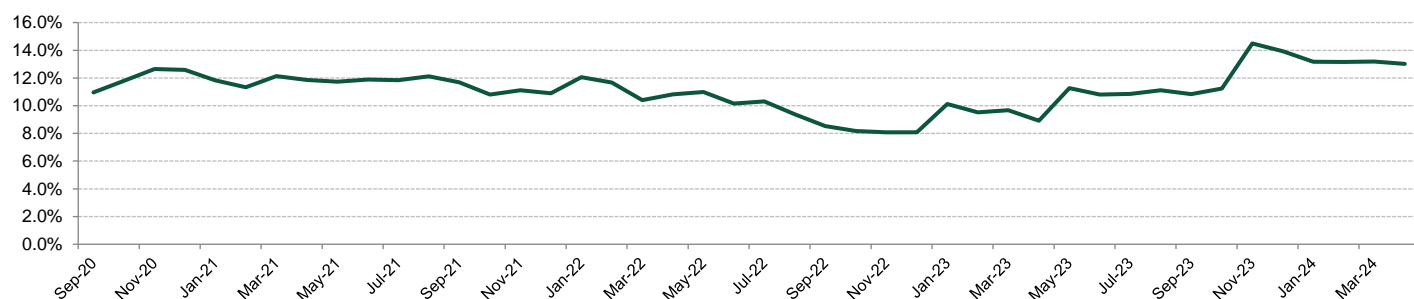

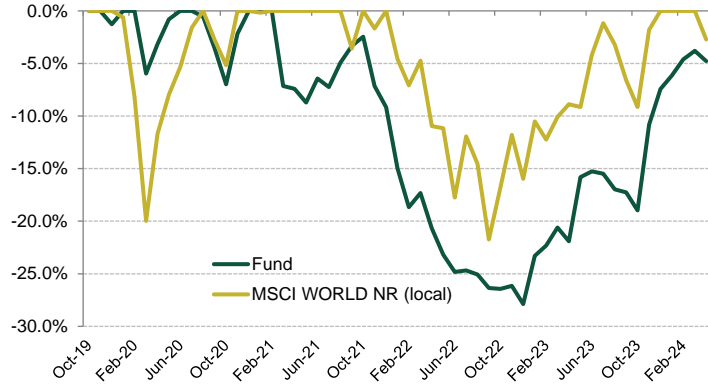

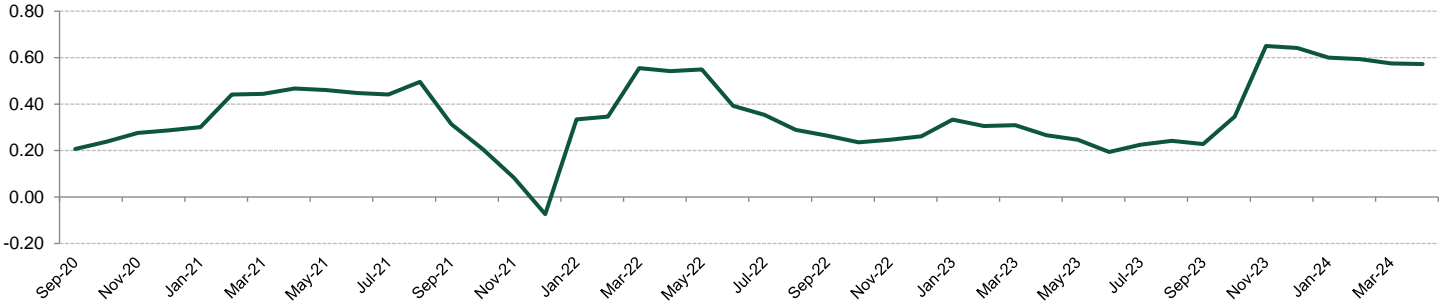

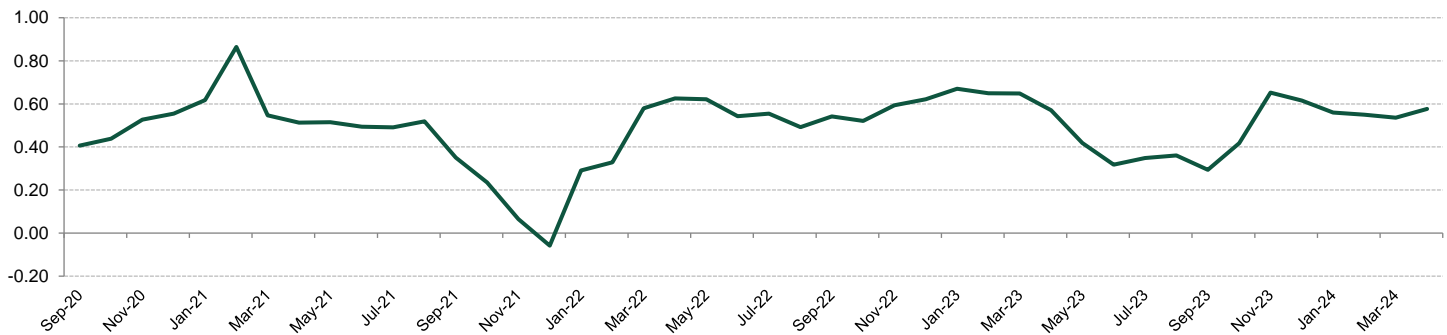

◆ 12 MONTH BETA EQUITY EVOLUTION



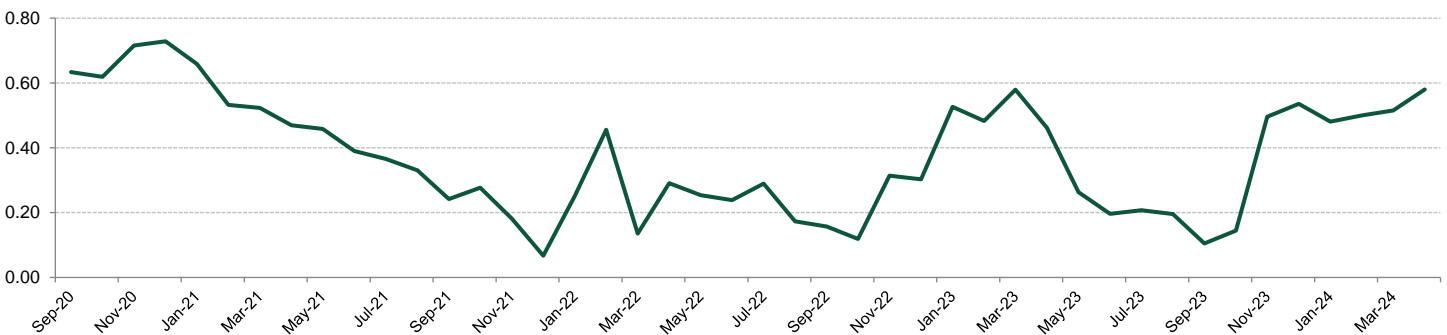
