UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing up to 100% in global hybrid securities such as: - Contingent Convertibles capital bonds ("Cocos") with specific loss-

absorbing mechanisms including permanent write-down, temporary writedown or conversion into equity

- Hybrid securities such as financial and non-financial subordinated debt. The Fund is allowed to invest without limits in currencies other than its

base currency (US Dollars). However, the currency risk is limited to 10% of the nets assets.

The Fund is actively managed and well diversified. The Fund is not managed in reference to a benchmark.

The Fund may invest up to:

- 100% of its net assets in Cocos
- 100% of its net assets in hybrid securities
- 100% of its net assets in High yield
- 30% of its net assets in Emerging markets (including China)

- 10% of its net assets in Equity

Cocos will have a minimum rating of B- (or equivalent), will be issued by banks whose parent company has a minimum balance sheet of USD 100 billion and whose parent company is domiciled in countries rated with a minimum rating of BB- (or equivalent).

Cocos can be, in accordance with regulatory capital requirements, converted into equity capital (shares) or face principal write down (in whole

Risk and reward profile

High yield rated securities and higher risk bonds are issued by entities whose activity is more sensitive to the economic cycle and therefore pay a higher interest rate than investment grade bonds to compensate for the increased risk.

The Fund's value is calculated and expressed in US Dollars. The currency risk in relation to the base currency USD is mainly hedged. The minimum initial investment is USD 50'000 or equivalent.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive markets are closed: United States (US), United Kingdom (UK), Eurex. The recommended holding period is minimum three years.

Any income received by the Fund is distributed (distribution share class).

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Counterparty risk: As the Fund uses over-the-counter derivatives, there is a risk that the counterparty to the transactions will wholly or partially fail to honour its contractual obligations. This may result in a financial loss to the Fund

Credit risk: The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade

Emerging market risk: The Fund invests in developing overseas markets which carry a higher risk than investing in larger established markets. Investments in emerging markets are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in emerging markets rather than more developed countries may encounter difficulties when buying and selling investments. Emerging markets are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.


