UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income by investing in a large diversified asset allocation including any kind of bonds including Convertible bonds and any kind of equities without any geographic constraints.

Exposure may be direct or through funds.

The Fund is actively managed and invests in a range of currencies. The currency risk associated may or may not be hedged at the investment manager discretion.

The Fund is not managed in reference to a benchmark.

The Fund may invest up to:

- 100% of its net assets in High yield
- 100% of its net assets in Emerging markets
- 100% of its net assets in Equity
- 20% of its net assets in Contingent Convertible bonds (CoCos).

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and therefore pay a higher interest rate than investment grade bonds to compensate for the increased risk.

The Fund's value is calculated and expressed in US Dollars.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg.

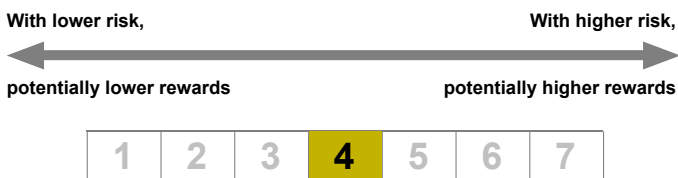

The recommended holding period is minimum three years.

As a Fund with mixed strategy, its holdings can move in line with or return less than the broad stock market, so investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.

Any income received by the Fund is reinvested (capitalisation share class).

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Risk Category 4 reflects average/moderate potential gain and/or loss in the value of the portfolio.

This is due to investments in bonds and equities on worldwide markets, including Emerging.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Counterparty risk:** The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honor its contractual obligations. This may result in a financial loss for the Fund.

**Credit risk:** The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Emerging country risk:** The Fund invests in overseas countries which carry a higher risk than investing in larger established markets. Investments in Emerging countries are likely to experience greater rises and falls in value. Emerging countries are also more likely to experience political and/or legal uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

## Charges

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.
