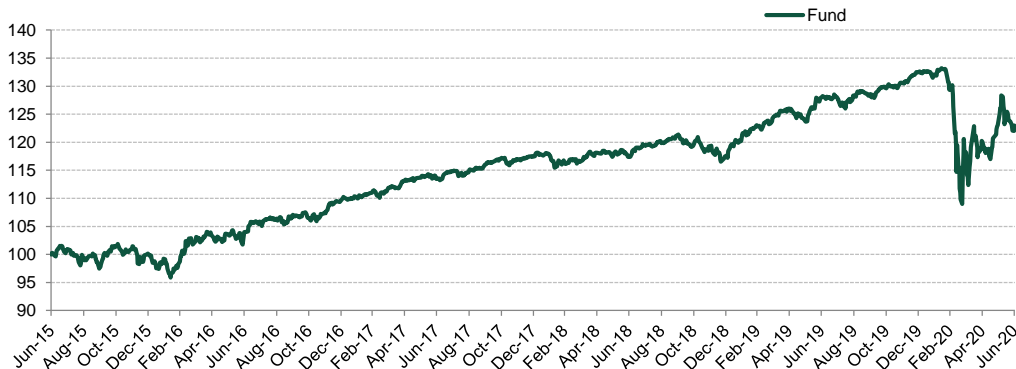

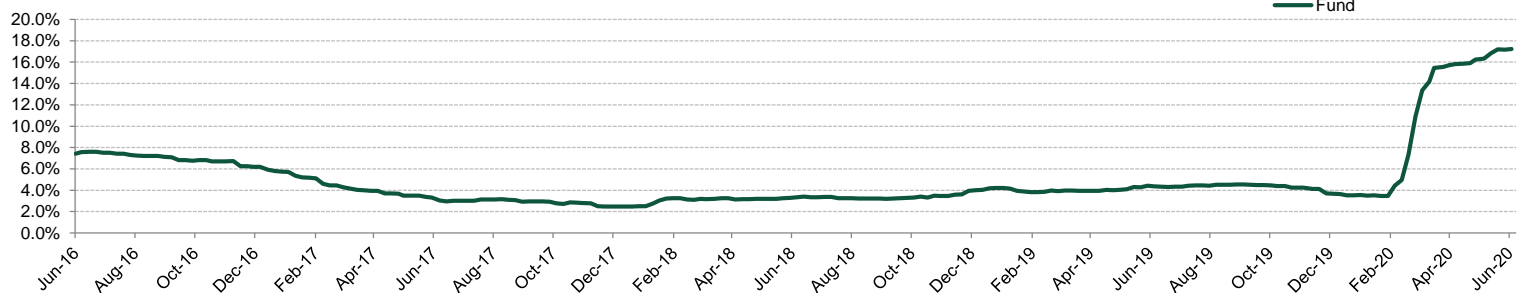
5-YEAR TRACK RECORD *

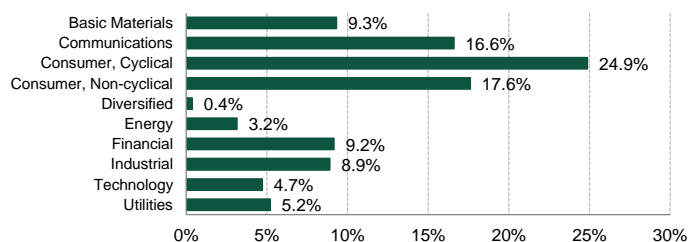

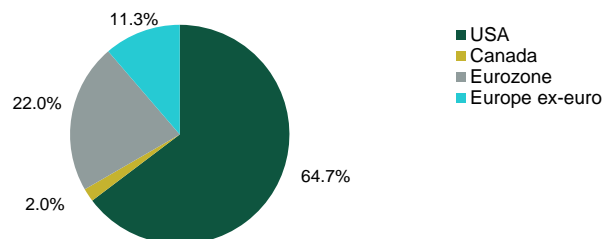
BREAKDOWN OF THE CDS INDICES EXPOSURE *



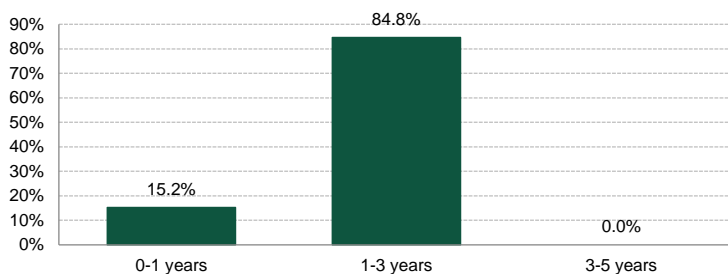

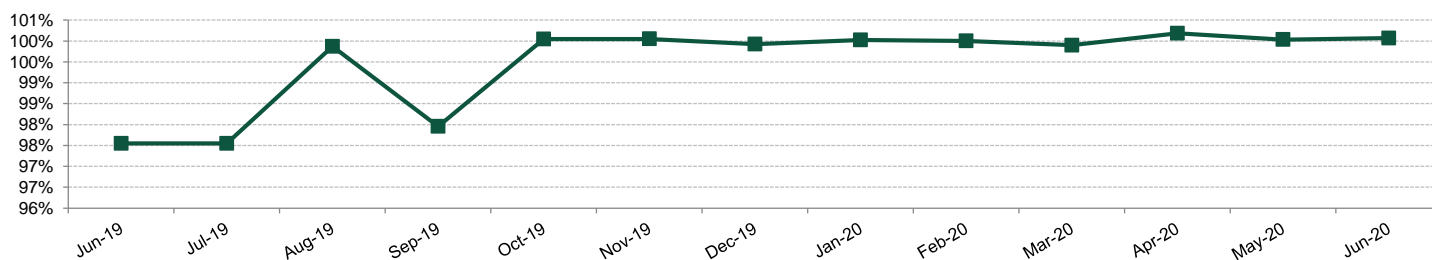

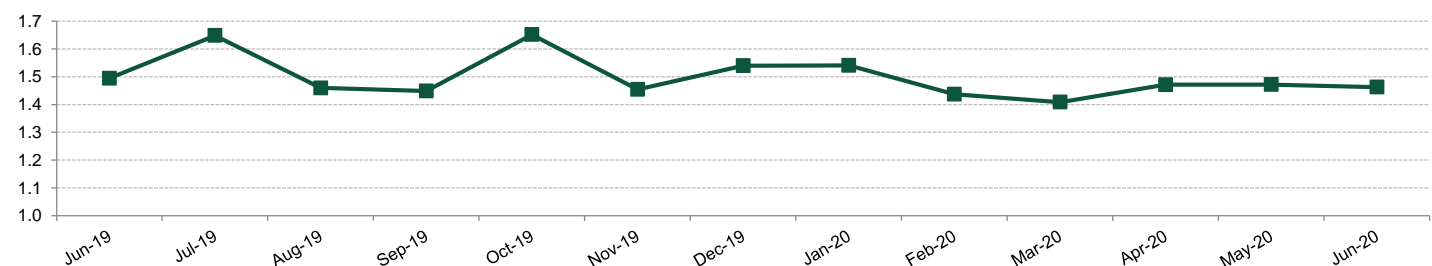

♦ CREDIT EXPOSURE



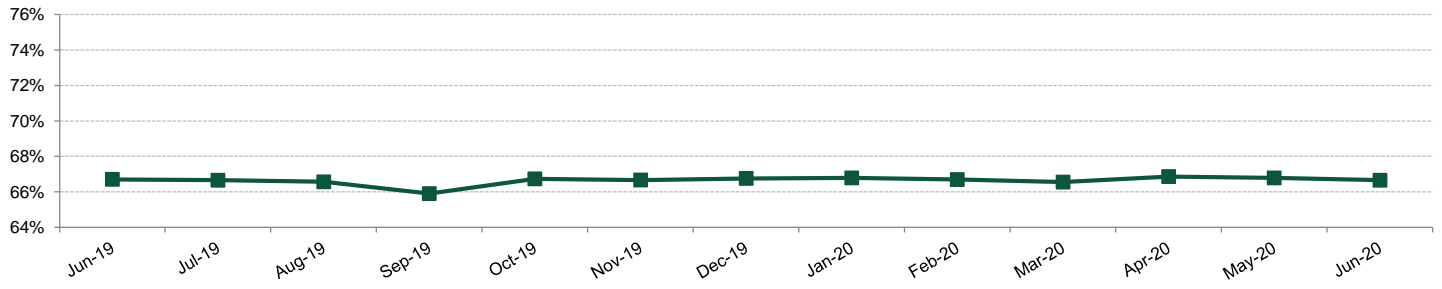

♦ INTEREST RATE EXPOSURE



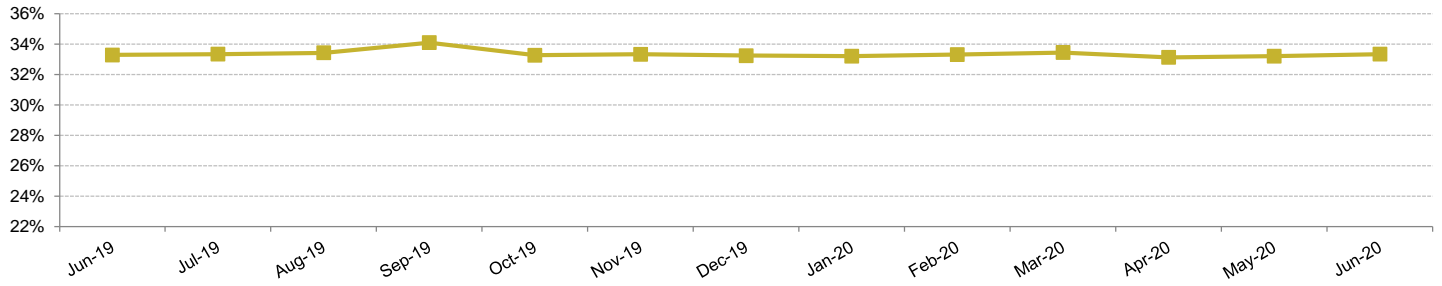
