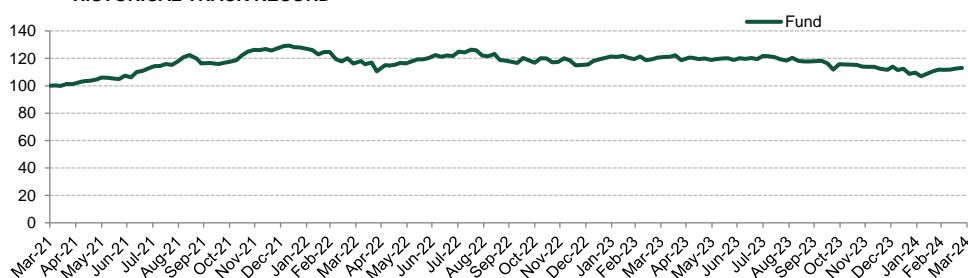

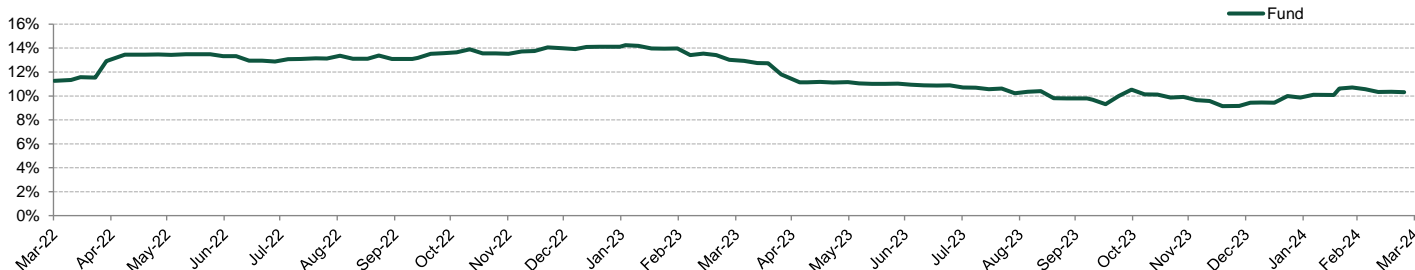

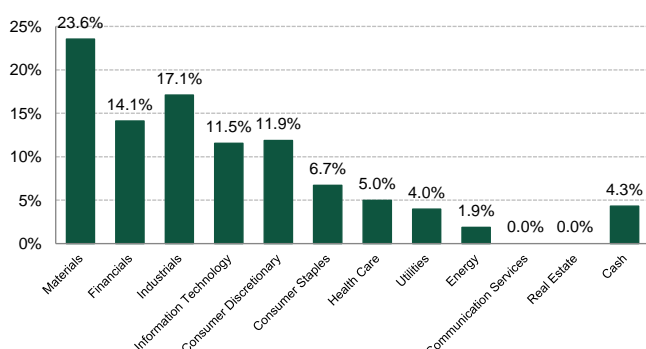

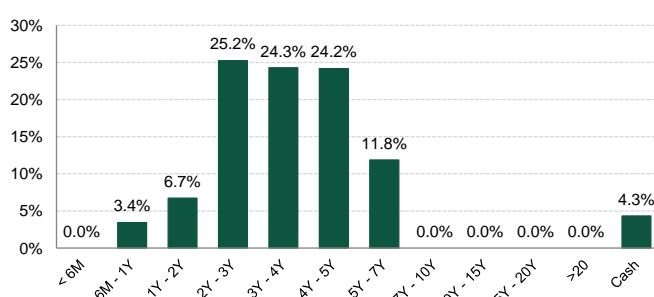

SECTOR (Weight)

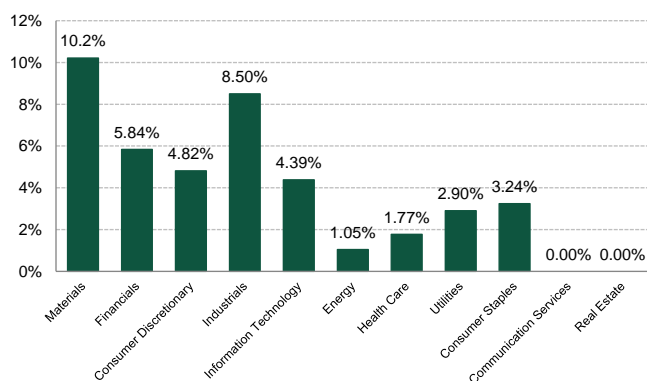

MATURITY STRUCTURE

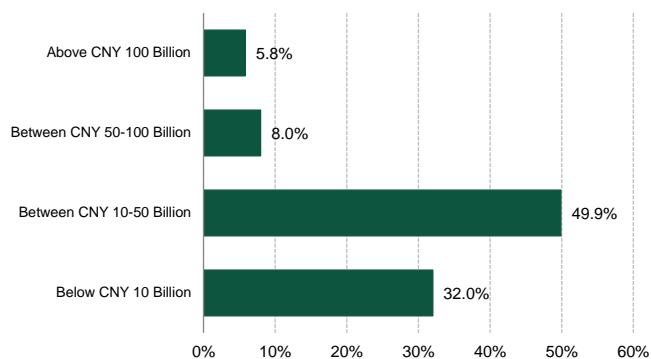


◆ SECTOR (Equity Sensitivity)

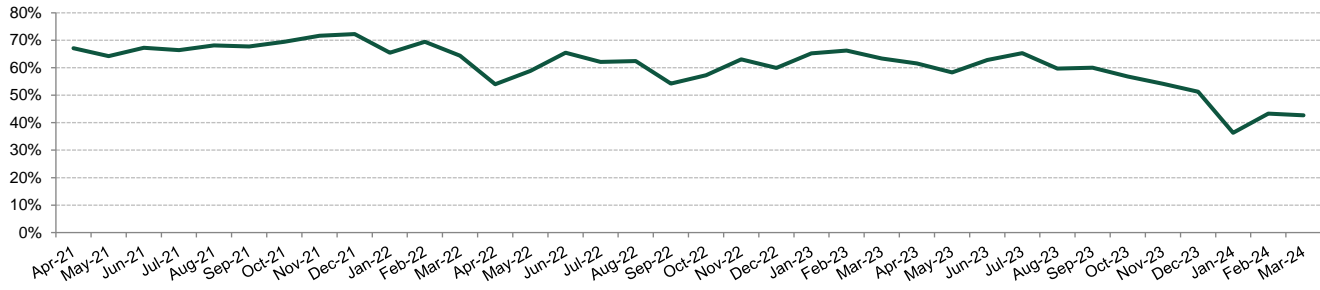

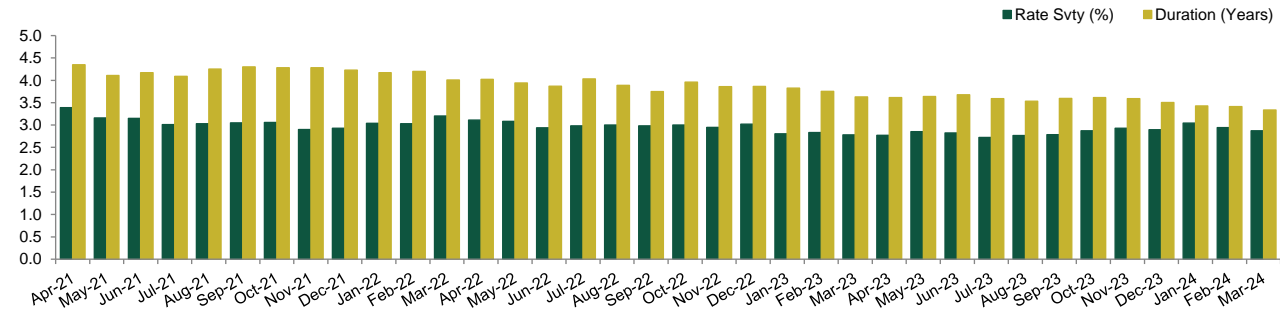
