UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in equities issued, for at least 75% of its net assets, in companies having their registered office in the European Union, in the United Kingdom and/or European Economic Area.

The Fund is actively managed and relatively concentrated, investing mainly in securities denominated in Euros.

The Fund is not managed in reference to a benchmark.

The Fund invests in stocks with an attractive yield over the long term. In addition, the Fund uses derivatives instruments including stock options and stock index options (i.e. covered calls strategy or puts selling) for effective management as well as for hedging purposes.

The use of these derivatives instruments will aim to increase distributable income and reduce portfolio volatility of the Fund.

The Fund's value is calculated and expressed in Euros.

The share currency risk in relation to the base currency EUR is not hedged.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg.

The recommended holding period is minimum five years.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

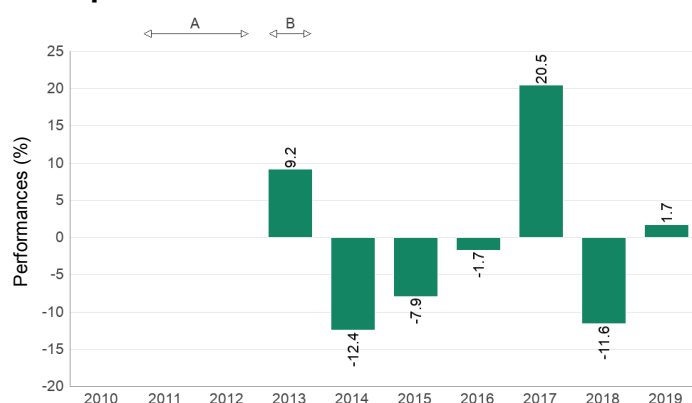
