UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

Objectives and investment policy

The Fund seeks to grow your capital and generate income primarily by investing in worldwide equities and other similar transferable securities of companies specializing in financial technology (Fintech).

The Fund is actively managed and selects financial technology or financial technology-related stocks world-wide, primarily companies which offering innovative financial products / services and companies offering Fintech technology/infrastructure, including services, software and hardware as a significant part of their business.

The investment strategy is focused on companies with strong and sustainable future growth, as well as high/stable or rising levels of Cash Flow Return on Investment (CFROI).

The qualitative sustainable analysis is partly based on inputs provided by MSCI ESG Research, and, for companies not covered by MSCI, on the own analysis of the Investment Manager.

The primary sustainable objective for which the Fund will be able to measure the positive impact is the lower carbon intensity versus the MSCI AC World ("the Benchmark").

The Investment Manager performs a negative screening and a norms-based screening to filter the investment universe. ESG related information is entering the suitability screen of the stock selection process. The portfolio construction will consider ESG criteria as well as the contribution to risk that arises from ESG exposures. Company specific and portfolio factors including ESG developments are considered when constructing and monitoring the portfolio.

A performance fee in reference to the Benchmark is applied to some share classes. The Benchmark is not representative of the Fund's risk profile and the portfolio's investments will deviate materially from the Benchmark's constituents in respect to countries, sectors, issuers and instruments, in order to align the portfolio with the environmental and/ or social characteristics promoted by the Fund and/ or in order to take advantage of specific investment opportunities.

The Fund's value is calculated and expressed in US Dollars.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg.

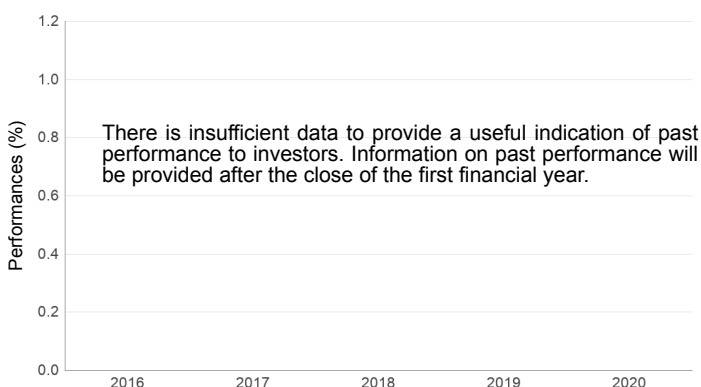
