

## KEY INVESTOR INFORMATION

This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

### UBAM - EM Sustainable Corporate Bond, a sub-fund of UBAM

UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in bonds whose issuer is a company domiciled in emerging countries, has an underlying instrument directly or indirectly linked to emerging countries or is a company whose risks are directly or indirectly linked to emerging countries.

On an ancillary basis, the Fund may be invested inter alia in bonds issued or guaranteed by sovereign issuers from emerging countries.

The Fund is actively managed and well diversified, investing mainly in currencies of OECD countries. The foreign exchange risk against US Dollars will be largely hedged.

The Fund is not managed in reference to a benchmark.

The Fund invests in bonds with a minimum credit rating of B- (Fitch, Standard & Poor's) or B3 (Moody's) and, as an exception to this rule : up to 15% of the net assets in bonds with a rating below B- (Fitch or S&P) or B3 (Moody's), and up to 15 % of the net assets can be invested in non-rated bonds.

The Fund invests in bonds with minimum BB ESG rating from MSCI ESG Research and does not carry a Red controversy flag by MSCI ESG Research. As an exception to this rule, up to 5% of the net assets can be invested in bonds without MSCI ESG Research rating. For the bonds without MSCI ESG Research rating, the ESG analysis has to be conducted by the Investment Manager.

The Fund may invest up to:

- 100% of its net assets in Emerging markets  
*this exposure can be increased up to 120% through derivatives*
- 20% of its net assets in Contingent Convertible capital bonds (CoCos).

The Fund's value is calculated and expressed in US Dollars.

The currency risk in relation to the base currency USD is mainly hedged.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg.

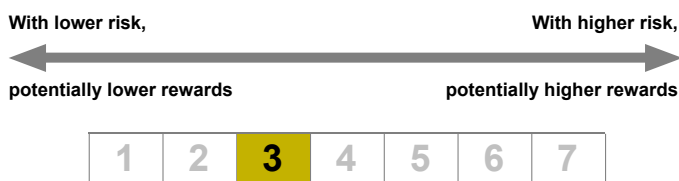

The recommended holding period is minimum three years.

Any income received by the Fund is reinvested (capitalisation share class).

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Risk Category 3 reflects limited potential gain and/or loss in the value of the portfolio.

This is due to investments in fixed income securities on Emerging markets. Historical data such as that used to calculate the synthetic indicator cannot be considered as a reliable indication of the Fund's future risk profile.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Counterparty risk:** The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honor its contractual obligations. This may result in a financial loss for the Fund.

**Credit risk:** The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Emerging market risk:** The Fund invests in developing overseas markets which carry a higher risk than investing in larger established markets. Investments in emerging markets are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in emerging markets rather than more developed countries may encounter difficulties when buying and selling investments. Emerging markets are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

## Charges

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.
