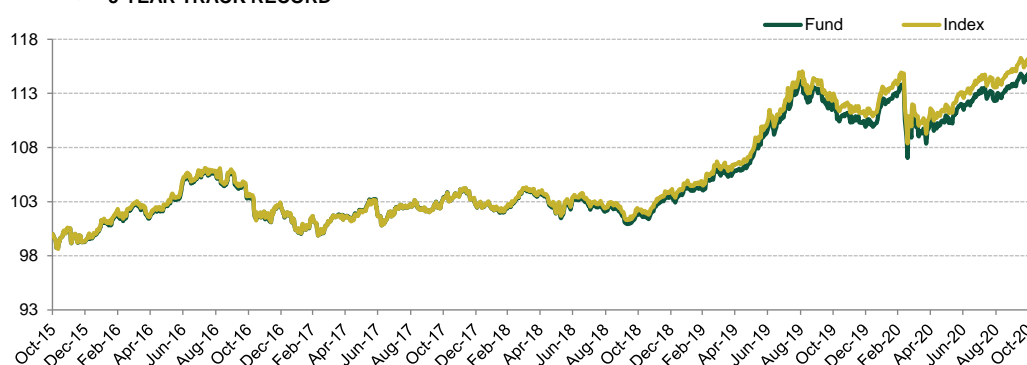

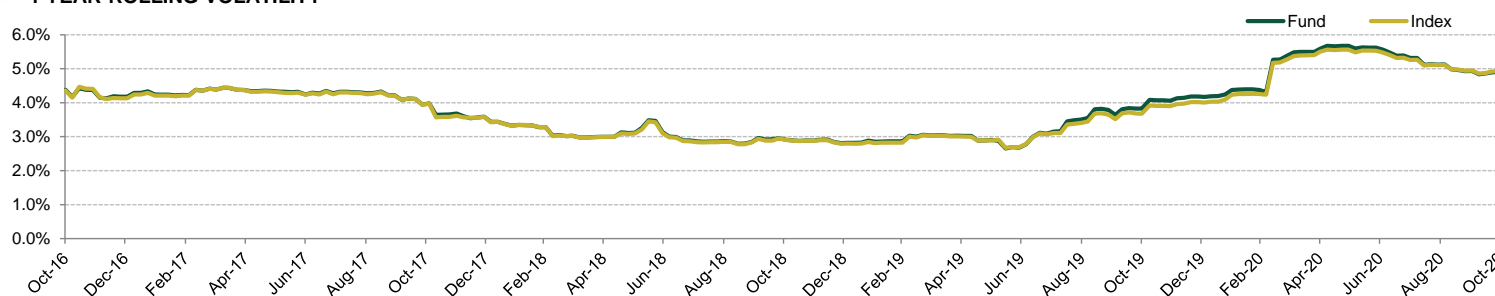
5-YEAR TRACK RECORD *

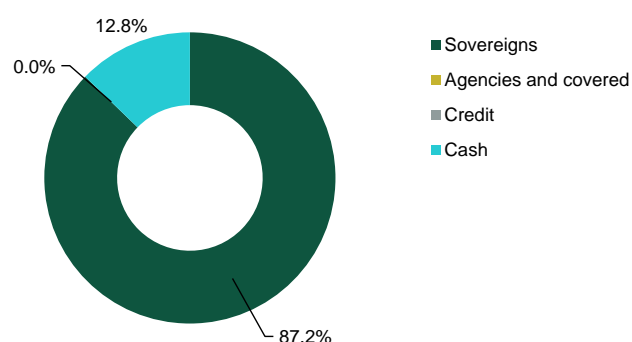

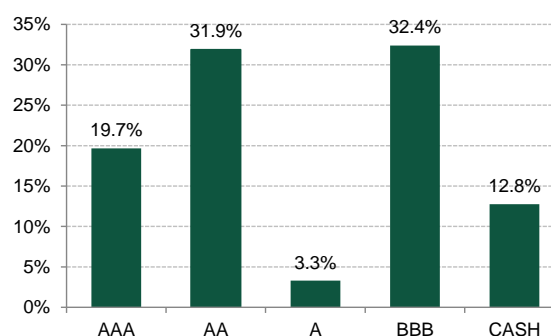
SECTOR ALLOCATION *

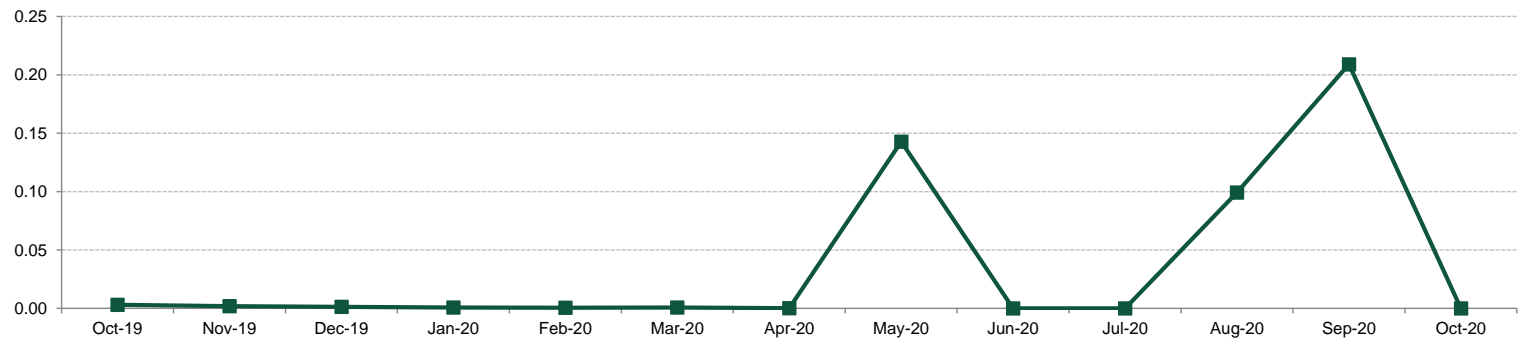
