UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in Japanese equities.

To achieve this objective, the Fund will adopt an active and selective policy to pick the stocks of Japanese companies notably likely to comply with the following criteria:

- equities that are undervalued due to a significant drop in their share price due to market factors (e.g. lack of liquidity, major profit-taking, sales momentum, temporary fall in profits), whereas their fundamental qualities remain unchanged and/or their profits offer the potential for a quick recovery ("fallen angels", small and mid-caps, etc.);
- accelerated restructuring of certain key sectors (e.g. retail, pharmaceutical industry) brought about by the reform of the Japanese law governing commercial companies, facilitating mergers and acquisitions by foreign companies, as well as business combinations between Japanese firms.

The minimum market capitalization of selected companies will be JPY 10 billion.

The Fund is actively managed.

A performance fee in reference to the MSCI Japan Small Cap Net Total Return Local Index is applied to some share classes (the "Benchmark"). The Benchmark is not representative of the Fund's risk profile and the portfolio's investments will deviate materially from the Benchmark.

The Fund's value is calculated and expressed in Japanese Yen.

The currency risk in relation to the base currency JPY is mainly hedged.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: Japan (JP).

The recommended holding period is minimum five years.

As an equity fund, its holdings can move in line with or return less than the broad stock market, so investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.

Any income received by the Fund is reinvested (capitalisation share class).

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Risk category 6 reflects a very high potential gain and/or loss in the value of the portfolio.

This is due to investments in small cap equities on the Japanese market. Historical data such as that used to calculate the synthetic indicator cannot be considered as a reliable indication of the Fund's future risk profile.

**Counterparty risk:** As the Fund uses over-the-counter derivatives, there is a risk that the counterparty to the transactions will wholly or partially fail to honour its contractual obligations. This may result in a financial loss to the Fund.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.

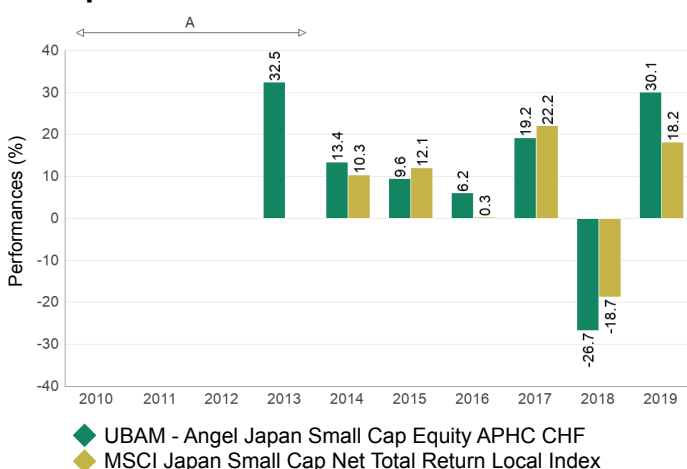
