Market Comment

- The first quarter of 2023 saw a continuation of the rally in risk assets that started in Q4 2022, as markets were pricing that peak interest rates are behind us. Markets continued to be volatile over the period however; The quarter started with very strong rally in January, followed by a strong correction in February and was punctuated by the crisis of confidence in US regional banks and the takeover of Credit Suisse by UBS. Government guarantees on deposits and central banks increased dovishness managed to calm down markets, which ended march in positive territory. In terms of regions, Developed Markets outperformed Emerging Markets, with Europe continuing its strong run since the second half of 2022. Fixed Income markets rallied across the board, driven by High Yield, Investment Grade, but also Government bonds and EM debt. Commodity prices ended the quarter in negative territory.
- On the economic front, some positive surprises on global growth, along with the reopening of China had a positive effect on business sentiment, which helped push equity markets higher. Headline inflation continued to ease on the back of low energy prices but core inflation remained stickier, prompting the fed to hike rates further in March, despite the instability within the banking system. Markets continue to be macro driven, focusing on the Fed and economic data. A growing consensus points out to a upcoming recession, which could lead markets to focus on company fundamentals once again and dispersion could return as a result.
- The current market environment provides a very interesting set of opportunities for our U Access (IRL) Trend Macro fund, which offers access to diversifying risk drivers and exposures by seizing long and short investment opportunities across mainly interest rates, credit and currencies, both in Developed and Emerging Markets. It has historically shown a low correlation to traditional assets.

Performance Review

- For the first quarter of 2023, U Access (IRL) Trend Macro returned +0.06%, (Class B USD, net of fees). Overall PnL for the quarter was +1.0%. In terms of contribution by asset class: FX led positive contributions (+0.7%), followed by Credit (+0.7%), while Rates (-0.3%) and Equity Indices (-0.4%) detracted performance for the quarter. Corporate Credit was the largest contributor (+1.3%) and the short CDX HY position was the largest detractor (-1.1%).
- Other positive performance in the quarter came from China Quasi Sovereign (+72bps), Nigeria Credit (+34bps) and US Front Ends rates (+34bps). Other negative performance from the quarter came from Tunisia Credit (-63bps), JPY 30-Year rates (-50bps), and US Flattener (-32bps).



Portfolio Activity

- **Fixed Income:** The heightened volatility in the rates market due to the SVB events led us to liquidate our rates positions in the US, EU, and JPY in March. We also established positions in select emerging and frontier markets like Egypt, Nigeria, Kenya, and Tunisia, taking advantage of the spread widening that took place in the market. We re-entered some of these trades at levels that were similar to when we initially entered them in early 2022. In China, housing sales and prices both improved in Q1. This was seen in both the primary and secondary market, indicating pent-up demand released after China emerged from a 3-year Covid lock down and as policies announced since November work its way into the system. We continue to hold this portfolio since it still trades at what we believe are very undervalued levels.
- **FX:** We saw opportunities being short dollar vs EM FX (Colombia, Kazakhstan, and Hungary). Our focus is on countries with a dislocation in their currency, high carry and current account stability.
- **Hedges:** We continue to use CDX HY and equity options as a portfolio hedge. Our focus remains firmly on actively managing these hedges to protect against potential risks while preserving portfolio value.

Outlook

- The U.S. interest rate markets are currently untradeable and has been a challenge for investors as volatility remains high, and unpredictable. At present, the market is pricing in one last hike in May and rate cuts starting in July, however, our research tells us that there is no clear path to any cuts this year unless there is a full-on banking crisis, which we do not foresee at this time.
- This year, markets have experienced choppy waters due to uncertainty around policy and lack of investor confidence. In our view, two things must happen to restore market confidence: first, the notion that the U.S. is headed into a deep recession must dissipate, and second, the recent trend of flight to quality in the stock market must reverse course. This trend has led to too many investors concentrating on a small number of stocks as everyone is searching for returns and looking to limit volatility. Our Team anticipates a mild recession for the U.S. in the near future, although the exact timing remains uncertain. We do not expect a rate cut by the Fed in 2023, as we believe inflation will remain sticky and could be closer to 3-3.5% by the end of the year.
