UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in Japanese equities.

The Fund is actively managed and relatively concentrated (typically containing 25-60 names) with low turn-over.

The Fund has two sustainability objectives:

- maintain an average portfolio's ESG score, based on the Investment Manager's analyses of companies ESG profiles using a proprietary scoring methodology, above the median ESG Score.
- evaluate the strategies deployed by companies in the field of oil & gas extraction and electricity generation to transition to a lower-carbon economy.

First step, the Investment Manager's applies ESG exclusion criteria, combined with its sustainability assessment of companies from the eligible investment universe defined as the best 300 Japanese listed stocks ranked according to the above mentioned ESG proprietary methodology among the 1000 most liquid Japanese listed stocks.

Second step, the Investment Manager's applies an ESG approach which is further embedded in the valuation and investment process of the Fund and the selection of stocks include ESG criteria when assessing stocks' fair value and normalized profitability.

ESG considerations may include carbon footprint as well as global norms compliance, social and corporate governance standards.

A performance fee in reference to the Tokyo SE (TOPIX) Total Return Index is applied to some share classes (the "Benchmark"). The Benchmark is not representative of the Fund's risk profile and the portfolio's investments will deviate materially from the Benchmark's

constituents in respect to countries, sectors, issuers and instruments, in order to align the portfolio with the environmental and/or social characteristics promoted by the Fund and/or in order to take advantage of specific investment opportunities.

The Fund's value is calculated and expressed in Japanese Yen. The currency risk in relation to the base currency JPY is mainly hedged.

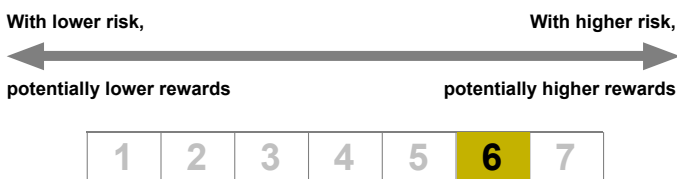
Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: Japan (JP).

Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.
