UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow your capital and generate income primarily by investing in Swiss equities.

It is an actively managed, concentrated portfolio of stocks mainly denominated in Swiss Francs.

The Fund invests in stocks that we believe will rise in value over the long term. We seek to invest in companies with the ability to generate high levels of cash.

The Fund's value is calculated and expressed in Swiss Francs.

The currency risk in relation to the base currency CHF is mainly hedged.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: Switzerland (CH)

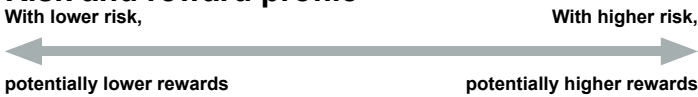

The recommended holding period is at least five years.

As an equity fund, its holdings can move in line with or return less than the broad stock market, so investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.

Any income received by the Fund is distributed (distribution share class).

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Risk category 5 reflects a high potential gain and/or loss in the value of the portfolio.

This is due to investments in equities on the Swiss market.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.

**Counterparty risk:** As the Fund uses over-the-counter derivatives, there is a risk that the counterparty to the transactions will wholly or partially fail to honour its contractual obligations. This may result in a financial loss to the Fund.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

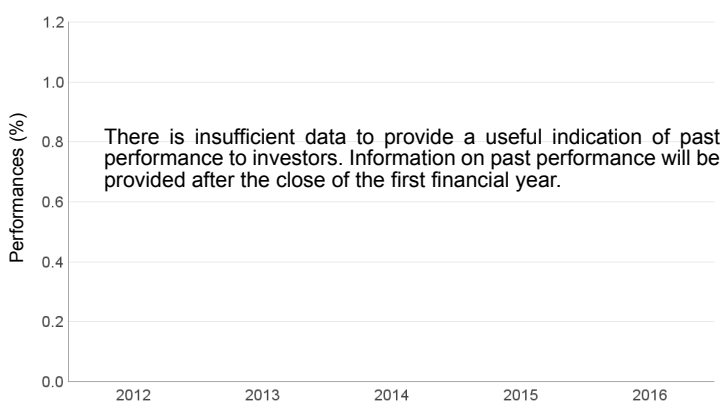
