U ACCESS is a SICAV managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income primarily by investing in Chinese equities and/or Chinese government bonds.

In order to achieve its investment policy, the Fund will invest through :

- the Shanghai and Shenzhen Hong Kong Stock Connect.
- the Bond Connect
- the Renminbi Qualified Foreign Institutional Investor ("RQFII")
- others stock exchanges such as but not limited to Hong Kong, Singapore, London and New York.

In addition, the Fund will use proprietary artificial intelligence model intended to provide a better risk adjusted return with lower volatility and reduced drawdown.

The Fund is actively managed investing mainly in securities whose value is expressed in Renminbi.

The Fund is not managed in reference to a benchmark.

The Fund's value is calculated and expressed in Renminbi.

The share currency risk in relation to the base currency CNH is mainly hedged.

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: Shanghai and Shenzhen (CN).

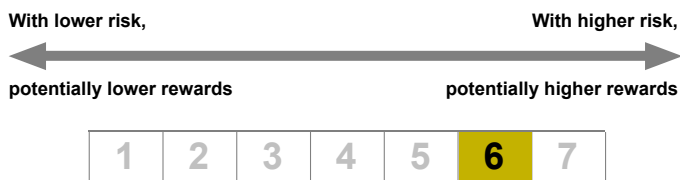

### Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

**Bond Connect quota limitations risk:** Investing via Bond Connect is subject to regulatory risks. Bond Connect is subject to quota limitations on investment, which may restrict the Fund's ability to invest in Chinese bonds through the Bond Connect on a timely basis and the Fund may not be able to effectively pursue its investment policy.

**Stock Connect quota limitations risk:** Investing via Stock Connect is subject to regulatory risks. The relevant rules and regulations are subject to change which may have potential retrospective effect. Stock Connect is subject to quota limitations on investment, which may restrict the Fund's ability to invest in China A-Shares through the Stock Connect on a timely basis and the Fund may not be able to effectively pursue its investment policy. Suspension risk may also occur. China Markets reserve the right to suspend trading if necessary for ensuring an orderly and fair market and managing risks prudently which would affect the Fund's ability to access the Mainland China markets.

## Charges
