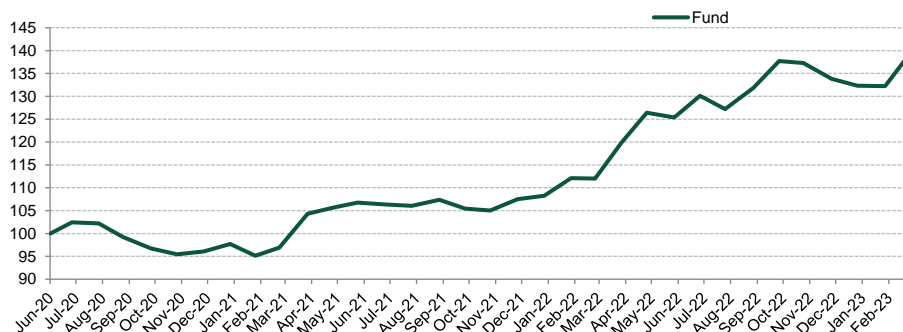

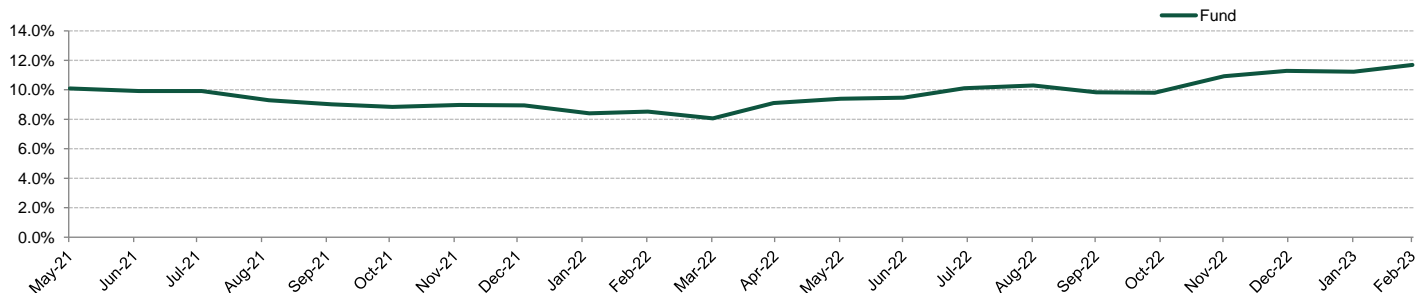
### HISTORICAL TRACK RECORD \*

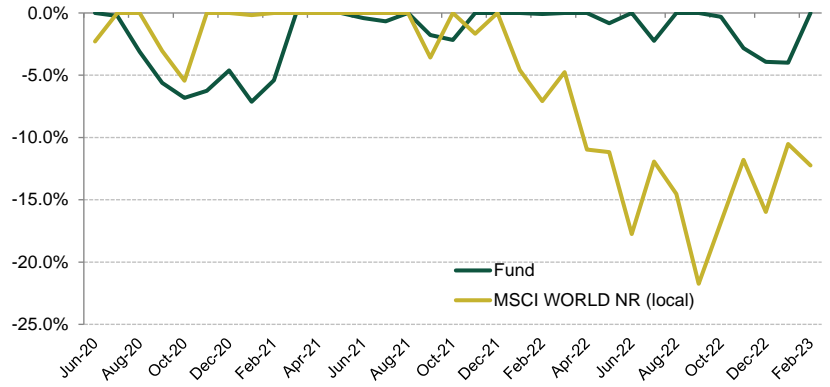

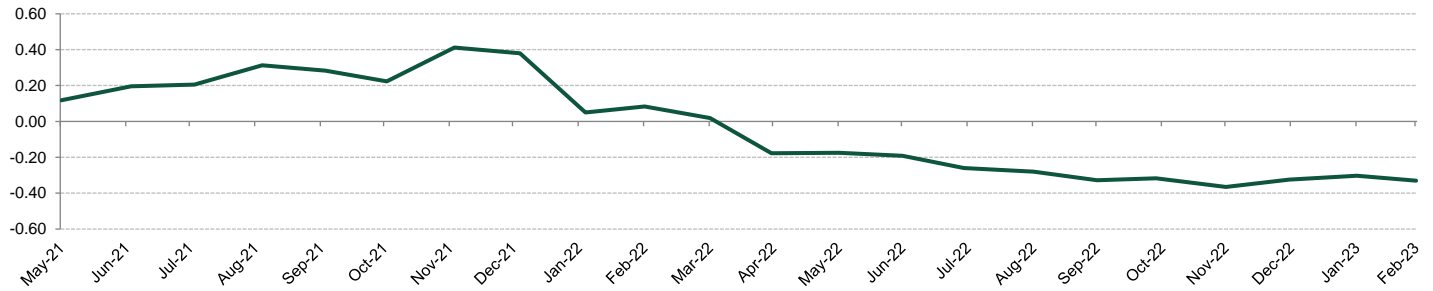

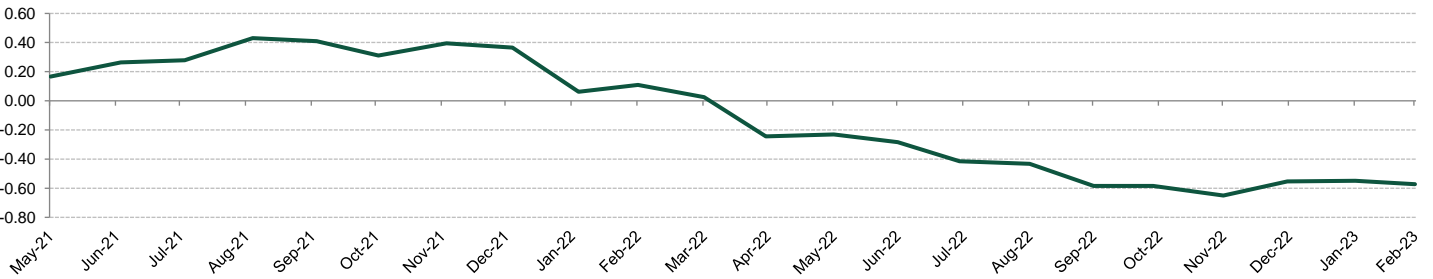

### ◆ 12 MONTH BETA EQUITY EVOLUTION



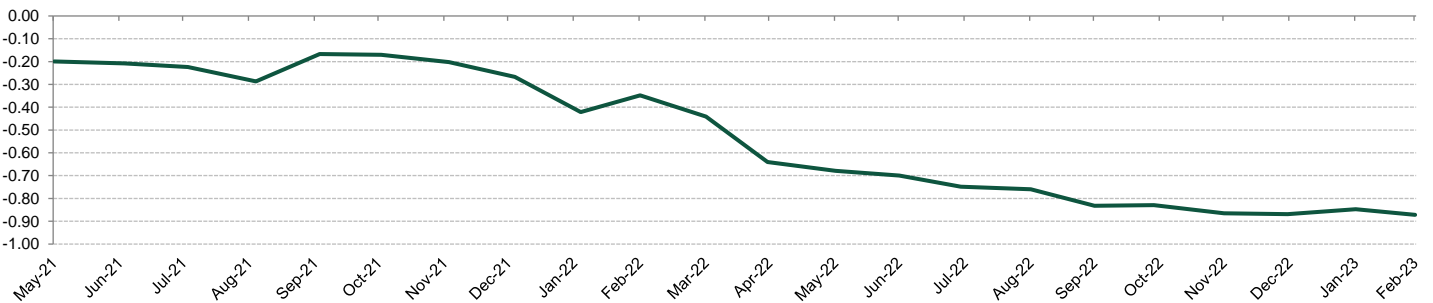
### ◆ 12 MONTH CORRELATION EQUITY EVOLUTION
