We are writing to you as a Shareholder of the Sub-Fund.

We hereby wish to notify you that the name of the Sub-Fund has been changed to ‘U Access (IRL) Bain Capital Global Equity LS Responsible UCITS’. This change is in light of ESMA’s Supervisory Briefing on ‘*Sustainability risks and disclosures in the area of investment management*’ dated 31 May 2022, which sets out principal based guidance on the appropriate naming convention of funds which fall within the scope of Article 8 of Regulation (EU) 2019/2088 (“**SFDR**”).

The change of name of the Sub-Fund was approved by the Central Bank of Ireland on 30 November 2022.


